### OPERATION READINESS

The plain truth is that if we cannot mobilize effectively and in a timely manner; we cannot fulfill our mission and succeed in a wartime environment. Failure to mobilize will almost certainly lead to failure of the unit ORI.

June 11, 1988 marked a planned test of readiness between the 154COMPG and 15ABW to check for bugs in the mobilization process. Lt Col Asai, Group Mobility Officer, says that "This is the primary means of determining our readiness and deployment capability". The exercise involved all mobilized units and a wartime scenario was acted out just short of sending people and cargo to their destinations.

Mobility has basically two areas: people and cargo. Processing units were set up to handle these areas and check if regulations were being followed. People are the "key" to a successful operation and according to Lt Col Asai, "Everybody's execution of responsibilities is crucial to fulfilling our mobility requirements".

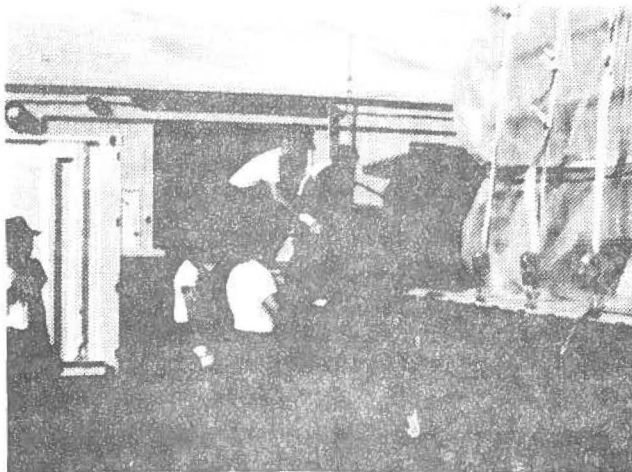

The 7th of June marked the close of the flying career of Colonel Larry Van Sickle, Air Force Senior Advisor to HIANG. Col Van Sickle plans to retire from the Air Force and will begin his new career as a civilian teaching F-15E students in the simulator. He will train for his new occupation at Luke AFB until February 1989 and then he will be working at Seymour Johnson AFB, N.C. Coming to us from the Red Flag Las Vegas unit, Colonel Van Sickle continuously sought to upgrade our 'dogfighting' capability by exposing our unit to better adversaries.

June commemorates the official start of our preparation for our impending ORI. We will be self evaluating our capability in many areas to insure our readiness. There will be many rules to follow and many administrative tasks to complete: updated ID's, physical fitness testing, current medical exam requirements, etc. We must be familiar with disaster preparedness signals and know our security requirements. When in doubt, don't assume...ask questions and let's get it right the first time.

This summer and fall we will be utilizing each UTA for significant group training. It is quite important to insure that you are personally ready to perform. For those in mobility roles, the challenge is even greater.

Our goal is to reach for maximum combat readiness through:

- Personnel use of tech data and checklists.
- Focus on management effectiveness without sacrificing people's concerns.
- Maintain high standards in quality control programs including an effective Stan-Eval Program.
- Realistic and practical safety program.
- Improving the skill level of our personnel in all areas.
- Commanders assuming unit responsibilities through effective leadership.

-Identifying problems in the organization and working to resolve them.

-Developing a plan for sound management to be implemented.

Nobody said this was going to be easy.

## F-15 GUNFIRING

The controlled airspace off of the southern Hawaiian Islands will be filled with the sound of 20 MM canon fire from the HANG F-15 Eagles during the period of 17-25 June, 1988. Using a (AGTS-36) towing target, which is shaped like a dart, the 199 TFS will conduct the first ever firing of F-15 canons in the state of Hawaii.

The 20 MM canons are an electrically controlled, hydraulically powered, air cooled, and forward firing gun mounted in the right shoulder area of the center fuselage. The gun is a rotating cluster of six barrels that fire once per revolution at a rate of 66 to 100 rounds per second.

Maintenance personnel and an instructor pilot from the 159 TFG (New Orleans, Louisiana) will conduct ground training to prepare our people for the exercises. Flying to be conducted during the period will consist of 84 shooter sorties and 28 tow target sorties. The air-air scenario will use three main flying patterns: Figure '8', Butterfly, and Combat. Each pattern represents a different level of experience with the F-15 canons. The Combat level is an exercise with no set patterns to simulate a war time environment.

# LEGAL BRIEF

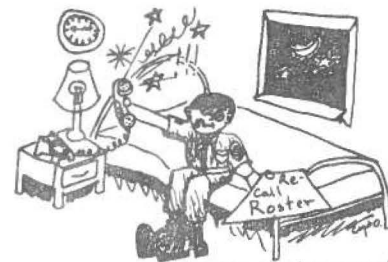


Not long ago a client charged with DUI sat in my office and stated confidently that he was not guilty because he was not driving when the police arrested him. He was fast asleep in the front seat with the engine off, and therefore he couldn't be guilty. While it is commendable that a person recognizes his inability to drive and chooses instead to sleep rather than drive, a recent appellate court decision has found that a car need not be in motion before a DUI violation can occur. This interpretation is derived from the comprehensive language of the DUI statute which states that a person commits the offense of DUI if he "... operates or assumes actual physical control of the operation of any vehicle while intoxicated. Finally a word to the wise, in light of the recent Makapuu accident which resulted in five deaths, you can be sure there will be a crackdown in the offing. So as Sgt Esterhaus used to say on Hill Street Blues, "Lets be really careful out there".

Recently, there has been a rash of HANG members referred to Social Actions for Driving Under the Influence (DUI). Why is there this increase in HANG DUI cases? We really don't know, however, drinking and in particular, drinking and driving is a matter of concern for all of us in Hawaii. To demonstrate, a recent Department of Education (DOE) survey titled "Student Substance Use and Abuse in Hawaii" reported that alcohol emerges as the substance of choice at all grade levels surveyed. Approximately 86% of the 12th graders used alcohol and more than 50% of these students were considered moderate or high users. An estimated 76% of these 12th graders drank beer some of the time, while nearly 1 in 5 drank weekly. Wine followed closely as the second alcoholic beverage of choice with 3 of 4 students drinking some wine. Hard liquor brought up the rear, with 63% of the students admitting to some use.

As for dangerous drugs, the most frequently used substances were marijuana (46% admitted some use) and cocaine (15% used).

Let's put this in some perspective, when you look at high school seniors, how many do you see smoking tobacco? The answer is about half. Well, just about the same number use marijuana. About one third more either drink beer or wine or both! Remember for these young people alcohol is consider an illegal substance.

The DOE report stated that students do not feel that the heavy use of alcohol is as harmful as other practices. Unfortunately, the view that heavy consumption of alcohol is not harmful is also held by adults as well as high school seniors. In some cases this view has resulted in DUI's, illnesses, marital or significant other problems, and the most tragic - traffic fatalities. Last year there were 75 traffic fatalities on Oahu, of these 37 fatalities were alcohol related.

It's a shame that this view or perspective on alcohol consumption has to die the hard way.

## SAFETY NOTES

We all know that the faster one is traveling when involved in an accident, the greater the chances of injury. But how fast is fast? When are the odds really against you.

Crash Speed (MPH)	Chances of Serious Injury	Chances of Being Killed
1-10	1 in 40	1 in 1000
11-20	1 in 10	1 in 250
21-30	1 in 4	1 in 30
31-40	1 in 2	1 in 7
40+	7 in 10	4 in 10

The physical damage received in an auto collision can be compared to falling off of a tall building from various heights.

Crash Speed	Equivalent Fall
20	13 feet
30	30 feet
40	54 feet
50	84 feet
60	121 feet
70	165 feet
80	215 feet

Simple translation - if a car moving at 40 MPH strikes a wall, or some other solid object, the unbelted passengers would fly into the dashboard and/or windshield with the same force with which they would strike the ground after falling more than 50 feet. AND YOU CAN GUESS WHAT THE RESULT WOULD BE. SO, DON'T SPEED, AND FASTEN YOUR SEAT BELTS.

## "MOVE EM' OUT"

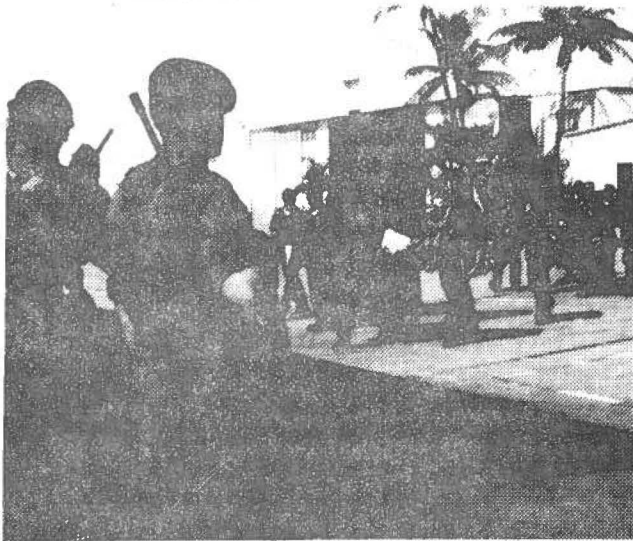

During previous months, units have been laying the groundwork for mobility by taking care of personal affairs. Dependant care, power of attorney, immunizations, finance, etc... are a few of the areas that absolutely have to be taken care before mobilization. "War is not convenient", says Lt Col Asai, and personal affairs are critical to ensure that families left behind are well taken care of.

Having people at the deployed site does no good if all of the equipment doesn't arrive as planned. Civil Engineers, Tac Hospital, Cam Squadron, Security Police and other mobilized units depend on materials to do their jobs. Imagine the Security Police setting up a perimeter at a bare base only to find out that the bullets did not arrive, ridiculous you say, but it could happen so double check your cargo.

The cargo side of mobility will go thru a joint inspection process by the 154COMPG and the 15ABW Air Cargo Terminal. Palletizing, labeling, packing, hazardous materials, and completeness will be checked to ensure compliance with regulations. This step is crucial and advance planning has taken place to inventory all materials to be deployed. Time requirements have been set at different phases of cargo loading to estimate the total time taken to deploy.

In short, we have to pull together as a cohesive force and accomplish all of the mobility goals that have been set forth. Areas that need to be worked on will be recognized and future planning will take care of it.
