FULL SPEED AHEAD!

That phrase probably best characterizes activities within the 154th COMPG now that Desert Shield/Storm is not the focus of all our attention. What follows is a quick recap of some of the things going on.

The availability of airlift as the requirements in the Gulf diminish is allowing not only other units to visit us, but us to resume training deployments as well. Currently here working with RMS is a group from the Alaska ANG. We're expecting another group from the California ANG later in the month. On May 4th, we're expecting six F-16's and supporting troops from the Arizona ANG here for two weeks for a "Sentry Aloha" flying exercise. They'll be accompanied by KC-135 tankers that will allow our flyers to update air refueling currencies. From May 10-26, the folks from the TAC Hospital will be off to Alpena ANG Base in Michigan for two weeks of medical readiness training. From June 29 through July 13, we'll be participating in the Red Flag exercise at Nellis AFB in Nevada with eight F-15's and a supporting package of mostly Ops and Maintenance folks. In August we're planning an in-house deployment to Barking Sands on Kauai to exercise our capability there for a week. The civil engineers have been hard at work on

Kauai remodeling temporary facilities for the 154th Tactical Control Squadron, whose mobile radar is due into Hickam from the mainland today. If a few last minute glitches can be worked out we hope to move into the new Avionics/Weapons Release building on April 15 and the Munitions Maintenance and Storage facility this summer.

The KC-135 initiative seems on track. Assuming the necessary approvals and announcements are made, we should have a cadre of ten to twelve people working that project full-time in October. On the F-15 side of the house we're anxiously awaiting a message confirming that we're to swap our jets for ones from Hollman AFB, N.M. that have been upgraded with the Multi-Stage Improvement Program (MSIP) modification. The "mod" represents a tremendous increase in combat capability and allows "A" models to carry the AMRAAM missile among other things. The swap is scheduled for calendar year 1992.

That's about it, yet I have a hunch I may have inadvertently left a few things out. These are definitely busy and exciting times for the COMPG and the HIANG! HIANG IN THERE!

To the soldiers and airmen, know that you are forever changed, touched by what you have seen, shaped by what you have experienced, bonded with those whom you have shared this trial. Know in your heart, most importantly, you were and forever will be equal to the challenge—you are Americans at their best.

God Bless You, The National Guard and the great nation we all serve proudly.

As our troops in Desert Storm fought our war with Iraq on the sands of Saudi Arabia and Iraq, they faced many times of both highs and lows. At times they wondered if they were ever going to come back home. During the low times, some of them remembered an uplifting story written by an unknown author as follows...

FOOTPRINTS

"One night a man had a dream. He dreamed he was walking along the beach with the Lord. Across the sky flashed scenes from his life. For each scene, he noticed two sets of footprints in the sand; one belonging to him, and the other to the Lord.

When the last scene of his life flashed before him, he looked back at the footprints in the sand. He noticed that many times along the path of his life there was only one set of footprints. He also noticed that it happened at the very lowest and saddest times in his life.

This really bothered him and he questioned the Lord about it. 'Lord, you said that once I decided to follow you, you'd walk with me all the way. But I have noticed that during the most troublesome times in my life, there is only one set of footprints. I don't

understand why when I needed you most you would leave me.'

The Lord replied, 'My precious, precious child, I love you and I would never leave you. During your times of trial and suffering, when you see only one set of footprints, it was then that I carried you.'"

Now, even if you didn't go to Saudi Arabia and had to face some very uncertain and low times, I'm confident there were times in your life that you did identify with the author of this story. I did. I hope our faith in God will help us to face all of the tough challenges ahead. All we have to do is notice those footprints.

FOR THE FAMILY

Most of us either remember what the old Hawaii was like or have heard stories of it. You could leave the doors of your home or car unlocked. You would feel a lot more confident that people wouldn't just walk away with your property. It was great. One of my friends would even leave the keys to his car in his car's ignition. He wouldn't even worry about whether his car would be still waiting for him when he'd return.

This isn't the case today. Homes are burglarized. Cars are stolen and taken on "joy rides." Property and valuables always need to be secured and protected. Even churches aren't protected and safe from the hit list of criminal activity. Hawaii just isn't as safe a place to live as it was before.

Thus security of our valuables is important. We need to keep our valuables in a safe and secure place.

A safe place to store our valuables is in a safe deposit box. Most banks provide these boxes for a reasonable fee, as low as \$20

per year but probably more like \$40 for the average person. Your valuables will be safe and accessible. You could store valuable things or documents such as: jewelry, your will, deeds, ownership papers, contracts, birth certificates, marriage certificate, savings bonds or whatever you consider valuable enough. These things would also be protected from the destruction of fire if your home became engulfed in flames. The main idea of what I'm saying is that I hope your valuables will be stored in a well designated, accessible and protected place.

I hope that the above information will help you plan wisely because I know that you care about your family. If you want more information that will help your family and other families, have your spouse or family member join a family support group. To do this, contact your unit.

ASBESTOS

(1st of 4 articles)

There are many important uses for asbestos. However, not everyone realizes the serious health hazard it can cause.

Asbestos is a mineral fiber found in rocks. These fibers are fire resistant and not easily degraded by natural processes. Therefore, they are not easily affected by heat, chemicals or electricity making them useful in industry and at home. However, these fiber masses have a tendency to break into tiny dust particles sending them airborne. Inhaling these particles makes it a health hazard.

If asbestos is so harmful why do we use it? We have been using this product for the past four decades. The building and construction industry uses it for strengthening cement and plastics as well as for heat insulation, fireproofing, and sound absorption. The shipbuilding industry uses asbestos to insulate boilers, steam pipes, hot water pipes, and nuclear reactors in ships. Because of its good friction and wear characteristics, asbestos is a component of the brake shoes and clutch pads of cars and trucks.

SECURITY AWARENESS

The members of the 154th Composite Group should be proud of the Excellent Rating for the January LUEI. I'm very proud of our personnel for their outstanding performance in security awareness.

The 154th Security Police Flight received an overall "EXCELLENT" in the LUEI. The areas that were inspected were the Command Support - Excellent, Operation Support - Excellent, and CATM-Satisfactory.

The rope along the Makai boundary of the Restricted Area was lowered to the ground and supported with rubber grommets instead of the pipe stanchions. This was done for safety reasons not to make it easier to walk or drive over the boundary. **USE THE ENTRY CONTROL POINTS AT ALL TIMES!** Crossing over a red line is a signal to the Security Police that you don't belong there (because you should know better) or that something is wrong (duress signal). **USE THE ENTRY CONTROL POINTS UNLESS YOU WANT UNPLEASANT ATTENTION.**

Aircraft that are being towed to the Wash Rack, Fuel Cell, or the Hangar can cross the boundary, once the 15th ABW/Security Police has been notified.

INFORMATION SECURITY:

A recent security incident happened that involved the disposal of sensitive data. Although the incident was not a security violation, appropriate measures should be taken to destroy the sensitive data.

Sensitive data should be destroyed through means of shredding, mutilation, or burning. **DO NOT, repeat, DO NOT** take sensitive data home to dispose of in a garbage dumpster or any dumpster outside the military base. Personnel information such as, SSAN, home telephone numbers, ect., is covered under the Privacy Act and should be destroyed properly.

Classified information will be destroyed by shredding or burning. Since the 154 COMPG does not have the equipment to burn classified material, shredding is the only way to destroy it. Contact your Security Manager for the locations of the shredding machines. Destruction of classified and sensitive material is covered in AFR 205-1, chapter 9.

REMEMBER! Security is everyone's responsibilities.

THERMAL UNDERWEAR FOR WEAR WITH BDU

Whether issued or individually purchased, is authorized for wear with the BDU. The exposed color of the garment must be olive green or brown. This requirement aligns with the recent 88th Air Force Uniform Board decision to delete wear of the white undershirt with the fatigue uniform. If the member chooses to wear a color other than olive green or brown, it is their responsibility to ensure the exposed portion of the thermals is IAW AFR 35-10. This decision may not be well accepted since white thermal underwear is an issue item. However, the BDU is intended to provide concealment for the member and wearing white underwear would deviate from this philosophy. The member has a number of options available to conceal the white thermals i.e. larger size T-shirts, turtleneck dickies, or turtleneck T-shirts. HQ USAF/DPU will explore the possibility of future procurement of brown thermals, for issue, to wear with the BDUs. (DPMA/449-5669)

SELECTION OF "BY LAW" ON SERVICEMEN'S GROUP LIFE INSURANCE ELECTION AND CERTIFICATE

1. Questions have been received from the field regarding the "BY LAW" election in part 2 of SGLV-8286, as pertains to the former spouse/current spouse.

a. Question: If a single member elects "BY LAW", later marries, and subsequently dies without completing a new form, who receives payment of proceeds?

b. Question: If a married member elects "BY LAW", divorces, then remarries, and does not complete a new form, who receives payment of proceeds upon death?

2. In response to these questions, the current spouse will receive payment of proceeds. The federal law stipulates that the payment of proceeds will be made to the spouse of the member at the time of death.

3. Although a member is not required to complete a new SGLV-8286, due to marriage/divorce, the member should be advised that complications could occur. The member may be referred to the local JAG if legal advice is needed. (DPMA/449-5669)

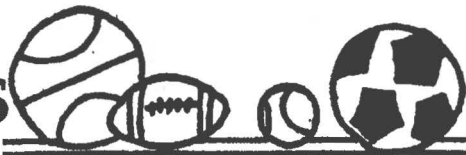
MONTGOMERY GI BILL EXPANDED PROGRAM

Several positive changes that took effect October 1, 1990 to the Montgomery GI Bill and expanded this already valuable program. These changes enhance the usefulness and salability of this benefit to prospective enlistees' while providing educational assistance unavailable to ANG members in the past. The expanded educational opportunities include financial assistance for

- * A second Bachelor's Degree (not a Masters) in a different field of study
- * OJT and Apprenticeship Training
- * Correspondence Courses
- * Independent Study (courses offered by accredited institutions without a regular class schedule)
- * Cooperative Programs
- * Vocational/Technical Programs
- * Deficiency/Remedial Programs
- * Flight Training

To qualify, ANG members must commit to six years after September 30, 1990. As before, the program will pay up to \$140 per month for full-time enrollment in a degree granting institution. However, for the newer programs now available, the amount of monthly benefits or percentage of fees paid for a course will vary. Be sure to consult the Veterans Affairs counselor at your selected school or contact the local VA office at 541-1000; neighbor islands 1-800-232-2535.
