Sumida. Col. Melvin Morris, 201CCGP will replace Col. Mizumoto as the DCM.

As the DCM, Col. Mizumoto exercised command and control over a consolidated aircraft maintenance squadron, and functional control over ground communications-electronics maintenance activities of two aircraft control and warning squadrons.

Col. Mizumoto was born on November 30, 1936 in Honolulu. He graduated from Kaimuki High School in 1954 and attended the University of Hawaii. He enlisted in the HIANG in March 1954 and attained the rank of Senior Master Sergeant in June 1964. He was commissioned as a First Lieutenant in May 1965 through the ANG direct commissioning program. He made Colonel on May 31, 1979.

Col. Mizumoto is married to the former Miriam Mimori of Lihue, Kauai. They have a son, Lance who is an officer in the HIANG and two daughters, Lori and Cari.

We wish the new HIANG commander good luck and know that he will continue his success in his new position as the "Air Boss".

# ASTRONAUT VISITS COMPOSITE GROUP

On June 14, Astronaut Charles Lacy Veach visited the Composite Group and gave a presentation on his recent mission in the space shuttle Discovery. Mr. Veach is a 1962 graduate of Punahou School and a 1966 graduate of the U.S. Air Force Academy. He earned his pilot wings in 1967. Over the next 14 years he flew the F-100, F-111, and F-105 fighter aircraft on various assignments including 275 combat missions in the Viet Nam War. In 1976 and 1977, he flew as a member of the USAF Thunderbirds.

Since leaving active duty in 1981, he has been an F-4 pilot with the Texas ANG. He started working for NASA in 1982 as an engineer and research pilot. In 1984 he was selected as an astronaut candidate and completed training in 1985, qualifying him as a space shuttle mission specialist.

### New DUI Procedure

Effective August 1, 1991, Hawaii's new DUI allows the revocation of your driver's licenses administratively.

Here is how the new law works:

ON THE ROAD. A police officer must have "reasonable suspicion" to stop a motorist, such as observing erratic driving or speeding; a driver can be stopped at a drunk-driving checkpoint. If the officer has "probable cause" to believe the driver is drunk, such as slurred speech or poor performance in a field sobriety test, the officer takes away the driver's license. The officer then issues a notice of administrative revocation, which serves as a 30-day driver's license unless the driver's license had already been revoked or suspended and the person is driving without proper authority.

The driver will be asked to take a breath or blood test to determine blood-alcohol content. If the driver refuses, the driver loses his or her license for a year

provided the police action is upheld.

ADMINISTRATIVE REVIEW. Within eight days of arrest, the administrative director reviews the police statement, blood-alcohol test, if available, and any written statements from the driver. The director then decides whether the license should be revoked based on a "preponderance of the evidence," meaning whichever side appears to have made its case. A driver has up to 60 days from arrest to ask for an administrative hearing on the director's decision. During the hearing, the driver may have a lawyer present, bring witnesses, and provide testimony. The administrative director then decides whether to uphold the earlier license revocation. The hearing must begin no later than 30 days after the request is made.

If the revocation is upheld, the driver may ask for a

review by a district judge.

ADMINISTRATIVE REVOCATION PENALTIES. Administrative revocation of a driver's license lasts for three months if the driver had a clean record for the previous five years, that means no previous administrative revocation, loss of license for refusal to take a blood-alcohol test or a drunk-driving conviction. The penalty is one year if the driver refused to take a blood-alcohol test.

The revocation lasts one year if the driver had one incident in the previous five years, however, the

revocation jumps to two years if the driver refused to take a blood-alcohol test.

The revocation lasts two years if there were two incidents in the previous seven years, and the license revocation goes to four years if the driver refused to take a blood-alcohol test.

The revocation lasts for life if there were three or more incidents in the last 10 years. (If the driver is a minor, the revocation lasts until the driver's 18th birthday.)

CRIMINAL PROCEDURES. Prosecutors may pursue criminal proceedings even if the driver is cleared in the administrative revocation process. However, no statements made by the driver in the administrative revocation hearing may be used against the driver in the criminal proceedings. Criminal penalties include license revocation, community service, stiff fines, and jail time.

Special note: Revocation under the administrative and/or criminal process means that the driver will not automatically get his or her license back once the penalty period is over. The driver must start all over again, by taking the long written test, the driver test, and also the driver will still have a record showing that his or her license was revoked.



-submission of bench stock requirements to 154 RMS/LGSDB.


-submission of individual equipment requirements to 154 RMS/LGSMR.

#### Asbestos in the Home

(4 of 4 parts)

Since asbestos is widely used in industry, could it exist in your home? Asbestos has been used in a wide variety of household products and home building. Some examples are appliances, ceilings, wall and pipe coverings, floor tiles and some roofing materials. So, yes, asbestos could be in your home. In the past, the use of asbestos was (1) to help strengthen a product's material, (2) for thermal insulation within a product, (3) for thermal or acoustical insulation or decoration on exposed surfaces; and (4) for fire protection. If you suspect that your home contains asbestos, it is best to leave the asbestos-containing material alone.

Asbestos becomes a problem when it becomes airborne. If you plan to renovate, have a survey done first by a professional. In general, home repair contractors are not experienced in the proper procedures for handling asbestos. Hiring a professional can help you to determine if you have asbestos. A professional knows where to look, the proper technique in obtaining samples and analyzing it, and offers technical advice about what is the best thing to do. Remember, removal of the material is usually the last alternative.

### LEGAL BRIEF

The following is an attempt to explain the new DUI law in plain terms:

If you are arrested for DUI, the police officer will ask you to take a breath or blood test to see how much alcohol is in your system. If you refuse to take either test, the arresting officer will type up a paper stating the reasons why he felt you were intoxicated, for example, erratic driving, smell of liquor, or failure of a field sobriety test. He then swears in front of a notary public that the statement is true. The statement then becomes an affidavit. Within a period of less than a month, you will meet with an administrative hearing officer who will review the case and decide whether the officer did have some reason to ask you to take a test. If he agrees, then your license is suspended for one year. It takes very little for the hearing officer to agree. The smell of liquor, for instance, is sufficient.

But that's not all: You still have to deal with the DUI offense. This is heard in District Court where the standard of proof is more difficult for the State to meet. If convicted for the first time, you face a 90 day loss of license (which really doesn't matter, because you already lost it for a year in the hearing), and or up to six months in jail, (although people rarely do jail time the first time around), and or a fine of up to \$1,000 and or a minimum of 72 hours community service.

Of course, if you elect to take a blood or breath test, all you face is the DUI trial.
