# 154th Wing Successful in CERI by SSgt. Stephen L Thomas

"Have a nice weekend with the Hawaii Air National Guard." Yeah, right. Last drill was a nice l-o-n-g, hot and rugged weekend for the members of the 154th Wing. All of our units were given the opportunity to "show their stuff" for the first time as a wing to the PACAF IG Team during a three-day Combat Employment Readiness Exercise (CERI). Our story made the front page of the August 15th edition of the Hickam "Kukini". If you didn't see it and would like a copy, stop by the 15th ABW PAO and ask for one.

Though most of us got to go home Sunday night and take a long-awaited shower, and catch up on some sleep, some members didn't get back home until a week later. Two of our KC-135 aircraft from the 203rd Air Refueling Squadron brought our 'deployed' members back home on August 14th. After processing through Customs, they were greeted with refreshments by Family Support Group representatives, and some were then transported by C-130 from the 204th Airlift Squadron to Barking Sands, Kauai.

In case you slept through it all, the Inspector General, HQ PACAF, conducted a Combat Employment Readiness Inspection (CERI) of the 154th Wing from August 8-12, 1997. This inspection measured the unit's ability to prepare personnel, weapons systems, and equipment for its wartime contingency tasking and sustain combat operations during simulated hostilities.

The 199th Fighter Squadron, the 203rd Air Refueling Squadron, and the 154th Logistics Group sustained combat operations at Hickam AFB, Hawaii, simulating employment of forces on the South Korean Peninsula and Japan. The 169th Air Control and Warning Squadron controlled flying operations from Wheeler AAF, Hawaii. The 204th Airlift Squadron and portions of the 154th Support Group and the 154th Logistics Group actually deployed to Elmendorf AFB, Alaska while the 154th Air Control Squadron deployed to the Republic of Korea.

The inspection was conducted under realistic combat conditions and in accordance with the guidelines established in PACAFI 90-201. Due to the complexity of this inspection, Air Force Special Interest Items were not inspected.

Three major functional areas were evaluated:

#### **Employment:**

- Offensive Counter Air
- Defensive Counter Air
- Air Refueling
- Tactical Airlift
- Theater Air Control System

#### **Mission Support:**

- Operations
- Logistics
- Support

#### Ability to Survive and Operate:

- Resource Protection
- Recovery Operations
- Self-Aid/Buddy Care

# Commander's Corner

by Maj. Gen. Michael H Tice. Commander, 154th Wing For those who could not attend the CERI outbriefing on August 22nd, or would simply like a printed copy of my comments, here they are...

I think I've just Wow! experienced the whole gamut of emotions ranging from excitement and extreme pride to some disappointment and a sense of frustration because we were not successful at achieving the overall ORI score we had hoped to for the Wing. This outbriefing started and finished on high with both the notes Employment score and recognition of our outstanding performers. What fell in between wasn't always pretty.

That being said, though, I think it's important for us to recognize what we did, and in most cases, feel very good about it; because there's a lot to feel good about. This was definitely the most thorough and challenging inspection the Wing has experienced in my 30 years as a member, and there's a lot we can learn from it.

First, we demonstrated that we do the big missions, the ones we do Monday through Friday ... flying ... extremely well. In the case of the 203<sup>rd</sup> Air Refueling Squadron and the 204<sup>th</sup> Airlift Squadron, we "closed the books", if you will, on their activations with this validation. 'Excellents' for employment on their first ORI in my book is as outstanding: is the 'excellent' achieved by the 199<sup>th</sup> Fighter Squadron. The 154<sup>th</sup> Air Control Squadron's Korean inspection validated their capability as well. As vou've heard me say before, everyone in the Wing in one way or another contributes to these flving missions ... and we all share in the successes the Ops Group achieved.

In the Mission Support area. Operations excelled again. The sortie generation efforts of the Logistics Group, in all three weapons systems, was excellent, in spite of some pretty adverse operating conditions. On the F-15 ramp, we learned a lot about extended operations in chemical gear. The PERSCO team, deployed to Alaska. excelled at their job too. Where we came up short was in two areas that don't get much "Monday through Friday" attention like the flying units do ... Engineering and Services. Was it unfair to pack them off Alaska for to an evaluation at a strange site? No. That's their job. Were they ready for it ... yes and no. In some cases, they lost site of some basic "standards" that should have been maintained. In others, we had simply not trained as

hard as we were evaluated. There's work to do here.

Ability to Survive and Operate is an area affecting everyone. The written report reflects both good and bad; selective. some some attributable to large parts of the Wing. The Civil Engineers' RRR showing is a concern and a disconnect of sorts because we don't afford them the opportunity to train, with any consistency, with the equipment they were evaluated on. We don't have it. That's another area we'll be focusing on.

Where do we go from here? There's both Strengths and Areas for Improvement listed that we can all learn from and Findings that we'll have to address. The worst thing we could do is say "Whew ... I'm glad that's over!" and put the report in the bottom drawer. We won't do that. Instead, we'll accept it as intended, a higher headquarters assessment of our capabilities acknowledging our strengths ... and identifying areas that we need to focus on to become a better Wing.

To Col. Rossa, Col. Hanson and the rest of the members of the PACAF "Bearcats", I say thank you. You and all the members of your team have a difficult job. Be assured your feedback to us is appreciated and we will act on it. To Col. Testa, Col. Walker and all of the members of the 15<sup>th</sup> Air Base Wing that were there to help us succeed ... I thank you.

So, how would I like the 154<sup>th</sup> Wing to leave here today? The same way I'm going to leave ... feeling good about the fact that we've proven our combat capability; and proud to be a member of this organization. The teamwork, energy, excitement and enthusiasm that was produced throughout the Wing, both prior to, during and after the inspection, has helped to bring us together as a team. We can't lose that. Should vou leave a little upset, too? You bet, because its the commitment to want to do better, working together, that's going to continue to make the 154<sup>th</sup> Wing great.

# Personnel News UNIFORM UPDATE: 154th MPF

#### Old-Style BDU ID Tapes ... Return

Aircrew style name patches will no longer be authorized for the battle-dress uniform (BDU), effective October 1, 1997, when the Air Force tape will once again be worn over the left breast pocket, and the name tape over the right pocket. The tapes will be green, and the lettering a subdued blue.

The PACAF patch will be worn on the left pocket and the Wing patch will be worn on the right pocket (upon availability). **\*\***Note, there is a new PACAF subdued (blue) patch; the old patch (green) is no longer current.

#### Stripes Return, Too

Effective October 1, 1997 all enlisted personnel will be required to wear stripes. The strips are new; larger and brighter.

The Master Sergeant grade now has one stripe over the top, the Senior Master Sergeant grade has two stripes over the top and the Chief has three stripes over the top.

Traditional Guard members may report to Supply this UTA to sign up for their name tapes and USAF name tapes. Technicians and AGR members may come in during the normal work week to sign up for their tapes.

#### **Cardigan Sweaters**

This is an optional item and members may purchase it at the AAFES Clothing Sales Store. The cardigan sweater can be worn by both men and women.

The following guidance on the wearing of the sweater applies:

\*The sweater may be worn with or without tie or tab, indoors or outdoors.

\*The sweater may be buttoned or unbuttoned indoors: it must be buttoned when worn outdoors. When buttoned, the sweater will be completely buttoned.

\*It may be worn with all available blue service uniforms to include maternity garments.

\*It will not be worn by hospital and food service personnel in lieu of the white cardigan sweater.

\*Rank/Insignia: Officers and senior NCOs will wear shoulder mark insignia. All other enlisted members will wear metal rank insignia. The insignia is to be centered horizontally on the epaulet with the bottom of the insignia one inch from the should seam.

**\*Fit:** The sweater, when buttoned, should not pull between the buttons. Epaulets should fit properly on the shoulders, not extending past the shoulder. Sweater length should be 4-7 inches below the waist.

Local commanders retain the option to require the wear of a tie or tab with all uniform combinations based on specific circumstances.

# Automated Awards/Decorations Training

# Tuition Assistance Program "Deadline: October 7th"

If you're thinking of using the HING Tuition Assistance Program (TAP) to attend the University of Hawaii system campuses for the Spring '98 semester, you need to submit your application to the Military Personnel Flight (MPF) ASAP. You need to completely fill out HING Form 1-R, dated <u>Spring 1998</u>, and HING Form 2-R. These forms must be signed by your unit commander and turned into 154 MSF/DPMH no later than 7 Oct 97. There will be no applications accepted after the suspense date.

TAP applicants have to meet all criteria listed in Policy Directive 1996-2. The most common problems we had this past semester were ETS dates during the applied period and members attempting to achieve more than one Associates or Bachelors degree. Member's ETS date must be on or after the end of Spring Semester, 1998. Unit members may contact SSgt. Carreiro at 449to make an appointment to 9056 Letters signed by unit extend/reenlist. commanders stating the member's intent to reenlist will not be accepted. Also, the intent of this program is to provide assistance for one Associates degree and one Bachelors degree.

In addition, there is a mandatory one-time submission of a student transcript from the school for which you are applying for tuition assistance and other colleges/universities attended. This will be used to establish acceptance to the school in a degree-seeking status, as well as a baseline for semester hours earned to date.

We are anticipating TAP requests in excess of funds available, so meeting the deadline is critical. Please plan ahead to

#### by MSgt. Laura Masuda. Bioenvironmental Eng. Svcs. Chemically Exposed Workers At The Jobsite (cont.)

Workers could be overly exposed to industrial chemicals during an incident, such as a hazardous spill. Knowing something about these chemicals provide knowledge in first aid, establishes greater respect when using these chemicals, and to handle them safely.

#### GASOLINE

Gasoline, a mixture of petroleum hydrocarbons, is produced by the distillation, cracking, and refining of crude oil. It is a clear liquid at room temperature and is a mild skin, eye, and respiratory tract irritant. It may cause a wide spectrum of central nervous system effects, ranging from mild confusion with minor exposures to seizures, loss of consciousness, coma, and even death with more massive exposures. Pulmonary aspiration of even small amounts of gasoline may cause chemical inflammation of the lungs.

If ingestion has occurred, do not induce vomiting. There is no antidote for gasoline poisoning, so initial treatment involves support measures. Patients who have significant exposure and have such symptoms as lethargy or continued coughing should be transported to a medical facility for evaluation. Patients who have ingested gasoline should have follow-up pulmonary function tests to ensure no damage to their lungs has occurred.

#### Legal Line

In 1993, President Clinton signed the Joint Ethics Regulation (JER) into the This comprehensive body of law is the realization of the effort to bring all the hundreds of federal agencies and the over one million federal employees under the umbrella of a single consistent ethics law. Good old AFR 30-30 is no more. All members are required to be familiar with the regulation as it is punitive in nature.

I recognize that the amount of information is voluminous and that the substance is not exactly "gripping", so I intend to give out only the high points and general concepts of the regulation in manageable, spoonful portions each drill.

APPLICABILITY

The JER plows new ground in that it applies to even traditional guardsmen, specifically when a member is performing official duties, including IDT or "...while earning federal retirement points".

HELP FOR THE CONFUSED

Each DoD component is required to have what is called a "Designated Agency Ethics Official" or DAEO (pronounced "dayo" -just remember Harry Belafonte: "Dayo, dayo, daylight come and me wan go home."). It is the DAEO's responsibility to administer the ethics program, and a big part of that responsibility entails answering questions as to the ethics regulation. If a member feels like he is in murky ethical water, the DAEO should have the answer. *Basic Concept #1* 

Do not use public office for private gain. To that end, members must be aware of "PROHIBITED SOURCES"; members may not receive anything of value from entities:

- seeking official action from agency,

- seeking or doing business with agency,

- regulated by the agency,

- substantially affected by the performance of your duties.

Members are allowed to receive gifts, etc. of no more than \$20 in value up to an annual maximum of \$50. If it exceeds these amounts, the member can either give it back or pay for the item, or if it is food or perishable item, donate it to charity, destroy it or share it with the office.
