# HANG RECRUITING INCENTIVE PROGRAM

Headquarters HANG received a \$750 grant from the Hawaii National Guard Association to be used in the recruiting program. The success of our recruiting program depends on the continued interest and support of all individuals in our units. There can be no doubt that the top man in the recruiting program is the Air Guardsman himself. The successful recruiter must be recognized. Therefore, the following cash awards are established, as indicated, from the HNGA grant: (a) Fifteen dollars (\$15.00) per female WAF-ANG enlisted. (b) Ten dollars (\$10.00) per male prior serviceman enlisted. (c) Five dollars (\$5.00) per male nonprior serviceman enlisted. All in-service HANG personnel are eligible for these awards. The excepted personnel, by the nature of their day-to-day tasks, are HANG CBPO's professional recruiters. These individuals are SMSgt Theodore Hussey, MSgt Darryl D. J. H. Ho, and SSgt Franklin T. Fujimura. HANG CBPO will prepare a monthly report of enlistments to HWAFC indicating the enlistee's name, date of enlistment, unit of assignment and the recruiter's name. Upon receipt of these reports, HWAFC will evaluate the report and make the award(s) as appropriate.

#### NEW MANNING DOCUMENT SOON TO BE IN AFFECT

A new manning document, 18 UE, will be creating some changes in the near future. The changes will affect the 199th FIS and the CAMRON more than any other areas. The 199th FIS will lose 3 pilots types and the CAMRON will lose approximately 56. The cause for the reduction in personnel is that the 154th authorized F102 aircraft was reduced from 25 to 18. This reduction took place in 1971 but the new manning document has just been completed. Reduction in personnel will be through normal attrition and will take effect within the next three or four months. Technicians are not affected.

#### "WHY?"

Why an Air National Guard? Are we a waste of the taxpayers money? Do we fly obsolete aircraft that can no longer do the job? Why do we exist? What's our purpose in life?

Recently several people have spoken via the written media, both for and against the Hawaii Air National Guard. Some of their observations are valid but most are not.

The Hawaii Air National Guard has a specific military mission as do all units of the Armed Forces. The Hawaii Air National Guard's mission is, put quite simply, to provide air defense for the State Of Hawaii. How the Hawaii Air National Guard does this, in detail, would lead to a lengthly article full of figures, statistics, computations, etc., so lets cut the gobblygook and talk in everyday language.

Is the F102 an obsolete aircraft? No! Not for what it was designed and the role it plays in the Air Guard mission, that of a defense against a manned bomber. The F102 is a fine and capable aircraft. It has the speed, range and ability to intercept, indentify and if necessary destroy the manned bomber threat. There is currently no known weapon defense against the ICBM and the F102 or any other aircraft in the Armed Forces inventory has never been designed to combat the ICBM. Our current defense against ICBM is our offense, the ability to retaliate against our enemy should he attack.

Are we necessary and do we waste the taxpayers money can be answered with very few words. Hawaii is a prime target area therefore its citizens and military installations must be defended in case of attack. The Hawaii Air National Guard maintains a fully operational Fighter Group, Aircraft Control and Warning Squadrons, Mobile Communications Squadron and all of the necessary allied supporting units at less than 60% of the cost that would be required by active Air Force units. This saves millions of tax dollars annually.

Why do we need less personnel than the active Air Force? Our day-to-day technicians and pilots work and live here. Hawaii is their home. This means continuous continuity and a very small turnover in people. These technicians and pilots are augmented by the balance of our Hawaii Air National Guard force who are fully qualified to do their job in time of need. It is this latter group of Guardsmen that are the prime reason for requiring less technicians and pilots thus creating the savings to the taxpayer.

Obviously we cost the taxpayer money. There isn't any branch of government on any level that doesn't cost the taxpayers money. We have shown that we are indeed a necessary part of Hawaii and have also shown our ability to provide that need at the least possible cost to the taxpayer.

Let's discuss briefly how we benefit the community over thd above our operational mission. We contribute millions of dollars annually in terms of salaries, local purchases, rents, mortage payments and yes, our share of taxes. Our non-technician guardsmen and pilots are required to be thoroughly schooled, at no cost to them, in whatever field they are assigned - jet engine mechanic, automotive mechanic, radar technician, supply specialist, radio operator, computor programmer, and many more. In every respect these skills can be applied to jobs in a civilian capacity here in Hawaii. Local businesses benefit by hiring these trained guardsmen and save countless numbers of dollars that would otherwise be spent in training. This savings can and often is passed on to the taxpayer.

The Hawaii Air National Guard is continuously participating in community events, clean up campaigns, assisting youth organizations, sponsoring sports events and much more.

Perhaps not all of the questions were answered but at least this has been a start at periodically reviewing ourselves. A start at answering some of the questions.

### DRESS AND PERSONAL APPEARANCE STANDARDS FOR AIR NATIONAL GUARD PERSONNEL

Comments in gaining command inspection reports are increasingly more critical of the dress and personal appearance of members of the Air National Guard. Air National Guard dress and personal appearance standards are clearly established and illustrated in AFM 35-10. There should be no doubt that these are Air Force and Air National Guard standards alike. The photo issustrations in Attachment 2 of AFM 35-10 which show acceptable hair styles are applicable to Guardsmen as well as members of the active Air Force. The personal interest and action of commanders at all levels is needed immediately to insure dress and appearance standards are met. This area will continue to receive the attention of all visitors and inspectors. Complicance requires strong leadership by example from every responsible member of the Air National Guard.

The 154th USAF Dispensary, HANG, now has two dental officers and necessary equipment to carry out prophylactic and some restorative dental treatment for HANG personnel. The Sunday afternoon period of UTA's has been block scheduled for this type of treatment. Unit Commanders have the prerogative of selecting personnel who would otherwise not be likely to afford private treatment and scheduling them for dental services. Contact 154th Dispensary for appointment on Sunday afternoon UTA's. Offering these services is in line with a USAF program to upgrade the dental status of military personnel above the minimum requirements and is part of HANG policy to build organizational pride and satisfaction by helping each other. Commanders may use their selections to reward the seserving, improve the overall unit status, or as an inducement for career service. Preference should be given first to newer EMs, career EMs, and finally to officers. this is not going to hurt.
