All civil service and military pay checks increased 5.5% effective on October 1. The raise is a result of legislation aimed at keeping federal salaries in line with private industry.

Guardsmen should already have oticed the change in their take-home pay. For instance the Sgt. with 4 years time in grade will takehome about \$3 more this time.

AIR GUARD-AIR FORCE RESERVE NOTE OF INTEREST.

INSPECTION OF ANG INFORMATION ACTIVITIES.

Increased interest by active force inspectors in the operation of ANG Information Offices has caused many inspectors to direct questions here regarding just what Air Force regulations these units can be held responsible for, in comparison with active Air Force Information activities. Basically, the inspectors are being told that Air Guard Information personnel should possess and be familiar with all 190 series regulations listed in the ANG 0-2 as being applicable to the Air Guard, plus any MAJCOM supplements to these regulations. A complete set of current 190 series regulations and manuals is desirable since many are used by the Guard for guidance.

DEFENSE MANTS 50,000 CALL-UP OK

WASHINGTON, D.C. (NGAUS) -- The Department of Defense will propose legislation authorizing mobilization of up to 50,000 National Guardsmen and Reservists for up to three months without prior congressional approval.

The announcement was made by William K. Brehm, assistant secretary of defense for manpower and reserve affairs, to more than 1,500 National Guardsmen attending the 96th General Conference of the National Guard Association of the U.S. in San Juan, Puerto Rico last month.

In commenting on expanded call-up authorizations, Brehm recognized that Guard mobilization, if granted, must be used judiciously. Otherwise, it could have an adverse impact on the Guard and Reserve recruiting and retention programs, he said.

In noting that the Guard and Reserves must be available "for a variety of circumstances," Brehm said the object of the proposal is "credibility," which must extend across the oceans to our allies and potential adversaries to maintain the deterrent value of our military forces.

The proposal also will help impress the active forces that the Guard and Reserves should have "meaningful missions" and davelop and interdependence between Active, Guard and Reserve forces, he said.

The National Guard Association is studying the proposal.
