

UNDESTRABLE DISCHARGE CERTIFICATES ABOLISHED

WASHINGTON (AFNS) -- Secretary of Defense, Donald Rumsfeld has announced that the military services will no longer issue the "Undesirable Discharge Certificate" (DD Form 258), to individuals being separated from the Armed Forces.

Beginning Jan. 1, 1977, members of the military services administratively separated for misconduct or security reasons (or who resign or request discharge for the good of the service when their conduct has made them subject to trial by courtmartial) will be issued a "Discharge Under Other Than Honorable Conditions" certificate. This certificate (DD Form 794) has been used in the cases of officers since October, 1954.

The change was recommended in conjunction with the Department of Defense's continuing review of its administrative separation systems.

No change is being made in issuing "Honorable" or "General" discharge certificates to those who perform successfully in the service of their country. Also, no change is being made to "Dishonorable" and "Bad Conduct" discharge certificates, which may be issued as a result of court-martial proceedings.

Beginning in June, 1977, former military personnel with Undesireable Discharge Certificates (DD Form 258) will be issued DD Form 794, upon application to their former service, in a manner to be announced at a later date.

NO OFFICER RIF IN FISCAL YEAR 1977 (Transmitted by message Dec. 27)

WASHINGTON (AFNS) -- The Air Force has announced that strength projections now indicate that an officer reduction-in-force (RIF) can be totally avoided in fiscal year 1977. A Reserve Officer Screening Board has not been planned.

Officials have been extremely concerned in the last three fiscal years over the requirement to involuntarily separate large numbers of officers. As a result, Air Force has aggressively pursued alternatives to minimize RIF.

Procurement during this fiscal year will continue to remain at levels which are well below normal. Additionally, many of the strength reduction programs employed in previous years have been extended into fiscal year 1977, including the recently announced rated and nonrated early release program.

The losses that are expected to occur from on-going strength reduction programs should be sufficient to reduce fiscal year 1977 officer strength to the current objective level.

199th WSO WINS 'TOP GUN' AWARD FROM EUROPE

Capt. William A. Jelks, a recently-arrived Weapon System Officer in the 199th Tactical Fighter Squadron, gets a "Top Gun" award this UTA weekend. Jelks earned the prize for being a "perfect bombardier" during his last six months on active duty with the United States Air Force in Europe.

Jelks not only outscored 50 other F-4 aircrews in bombing reliability, he was the only man in his wing -- the 52nd TFW, Spangdahlem AB, Germany -- to achieve 100 per cent strike reliability between 1 January and 30 June 1976.

Flying F-4C's on Gunnery and Bombing ranges in Germany, the Netherlands, Belgium and Spain, Jelks out-bombed all of his squadron mates in the 81st TFS; and also bested crews of the 23rd TFS flying the F-4D, which has a newer, more sophisticated bombing system than the *C' model.

The USAFE Top Gun Award is presented semi-annually to the WSO who achieves the highest training reliability on three types of bombing runs: 1) Radar Laydown, 2) Low Angle Drogue Delivery (a kind of pop-up and "lofting" of the weapon in a trajectory toward the target while the fighter recovers and scoots away), and 3) Radar Bomb Scoring (electronically-simulated attack).

Jelks did this while flying a variety of day/night attack training missions in both visual and instrument flight conditions at altitudes ranging from 6500 feet down to 100 feet, or "on the deck" across the ranges and scoring sites.

In onjunction with the TOP GUN award, Capt. Jelks also received the COMMANDER'S RECOGNITION CERTIFICATE from Maj. Gen. Benjamin Bellis, Commander, 17th Air Force, Sembach, Germany. He received this also for his achievements as or of Europe's top Wing Strike/Attack WSO's for the same six month period.

Getting the award is sort of like having your Wing Commander slap you on the back, grip your hand, and say "Outstanding," and "Well Done!" -- all at the same time. So now, one of USAFE's Best has become one of the Best of Hawaii's Best. Welcome and Congratulations, Bill Jelks!

FULL-SCALE DEVELOPMENT F-16 COMPLETES FIRST FLIGHT

The first full scale development version of the new F-16 fighter successfully completed its maiden flight at the General Dynamics plant at Ft. Worth, Texas. The first flight of the full size F+16 lasted about 80 minutes and consisted of checks on the aircraft's handling characteristics and major systems. It is a lightweight, low-cost, highly maneuverable fighter jointly being developed and coproduced for the tactical Air Forces of the United States, Belgium, Denmark, the Netherlands and Norway. Full-scale production of the Mach-2 fighter is scheduled to begin in October 1977.

HAIR WE GO AGAIN

There still seems to be some misunderstanding over certain male hair standards, so we thought we'd clarify a few points most frequently discussed.

Hair must not touch your ears when groomed and only the closely cut or shaved hair on the back of the neck may touch the collar. And, hair must present a tapered appearance on sides and back, both with and without headgear.

Hair must not exceed 1 and 1/4 inches in bulk, regardless of length and, naturally, must be well groomed. Further, hair must not touch the eyebrows when groomed, or protrude in front below the band of properly worn headgear.

If you sport sideburns, they must be neatly trimmed and tapered in the same manner as the haircut. The "burns" must be straight and of even width (not flared) and end in a clean-shaven horizontal line.

And a note about wigs: It must be of quality and fit, present a natural appearance, not interfere with the proper performance of duty, and must conform to the hair standards mentioned above.

AIR FORCE REVITALIZES PHYSICAL FITNESS PROGRAM

WASHINGTON (AFNS) - - Air Force officials have announced changes to revitalize the Air Force Physical Fitness Program (aerobics). The changes are included in a revision of Air Force Regulation 50-49 due soon to the field.

Aerobics revisions include revised testing, possible administrative actions against those who continually fail to measure up to fitness standards and more recognition for members who excell. Another major revision is the increased command emphasis on fitness.

One change to testing raises the aerobics test-passing standard from Category 11 (Fair) to Category 111 (Average). This will require, for example, a 33-year-old member to run 1 1/2 miles in the 12:30 to 15:00 minute range instead of the current 15:01 to 17:00 minute range.

Another testing change provides three fitness-testing options. These options are fast walking, running and running in place.

Other changes require review of all current test excusal waivers, participation by all medically qualified members regardless of age, and testing all members regardless of location with absolute minimum exceptions.

The AFR 50-49 revision also modifies fitness testing for Air Force women The revision eliminates the 10BX optional exercise program and adjusts aerobics and testing standards to accommodate participation in the program by women.

Possible administrative actions include a separation policy for repeated test failures.

In a letter to commanders of major commands, Air Force Chief of Staff Gen. David C. Jones noted that good physical condition is a vital ingredient in maintaining a well-disciplined, high-quality force.

AIR GUARDSMEN TO MARCH FOR PRESIDENT ELECT JIMMY CARTER

Exchange Privileges for Reservists and Guardsmen

The Department of Defense announced a change to the regulations on the use of exchange facilities by Reservists and Guardsmen. The identification document to be presented when exercising exchange privilege is affected by this change. The current control and identification procedures are outlined as follows:

- Unlimited exchange privileges are authorized for all Reservists and Guardsmen who perform inactive duty training, in a pay or non-pay status, on the basis of one day of exchange privilege for two inactive training duty drills performed.
- Reservists and Guardsmen may choose any day or days, within the validity period, that they will exercise the exchange privilege.
- Spouses may not enter the exchange alone but are allowed to accompany members. Other dependents are not authorized entry. All cash register transactions must be completed by the member.
- The Reservists or Guardsmen may be asked to present an identification card, DD form 2, upon entering the exchange unless the individual is wearing a military uniform. When a purchase is made, either the LETTER OF AUTHORIZATION (LA) or EARNINGS STATE-MENT (ES) is date stamped to indicate that a day of exchange privilege has been exercised. For the remainder of the date stamped, the LA or ES will be accepted as allowing the member unlimited exchange. privileges.

LETTER OF AUTHORIZATION

- is issued by unit commander or his designated representative.
- is to be used by Reservists and Guardsmen who perform inactive duty training in a non-pay status.
- contains the following information:
 validity period (12 months from date of issue)
 number of days of exchange privilege

- name and social security number of member
- name and social security number of spouse authorized to accompany member
- two blocks with numbers 1 to 10 for use by exchange personnel
- signature of unit commander or representative
- will be date stamped opposite Number 1 on the first block by exchange personnel to indicate that the member has exercised one day of exchange privilege.
 For the remainder of that day, the letter will be accepted as allowing the member unlimited exchange privilege.

EARNINGS STATEMENT

- is to be used by Reservists and Guardsmen who perform inactive duty training in a pay-status.
- is valid for 12 months from date of issue.
- contains the following information:
 - name of member
 - date issued
 - number of drills performed by member. (The member must calculate the number of days of exchange privilege by dividing 2 into the number of drills and then enter the number of days on the statement.)

The member may delete all other information on the ES.

- will be date stamped by exchange personnel when the member exercises a day of exchange privilege by making a purchase. For the remainder of that day, the ES will be accepted as allowing the member unlimited exchange privilege.
- does not provide for identification of the member's spouse. The spouse will be required to present appropriate identification (social security card or driver's license) when accompanying the member into an exchange.



- Reservists or Guardsmen who special order merchandise, purchase merchandise on a layaway basis or leave merchandise for repair will be permitted to complete the transaction on another day without having that day charged as another full day of exchange privilege. For the purpose of completing the transaction, they must produce the LA or ES as identification for the original transaction and a receipt which documents the original transaction.
