## General Ishimota Market Commanders

(At a Commanders meeting, Mail & worder, Brig Gen Arthur Ishimoto, HANG Commander, hit on many points repeating. We have reprinted his entire talk for we feel he has been excellent points which should be shared with all HANG'men, not in the mannaders.)

"The reason I have asked subort and sumit commanders to attend this meeting is to convey to you my con eadership. As I had mentioned in the previous commanders meeting and it is a science--it can be taught in a classroom. Leadership You must try various methods to make positive things happen.

"One of the main ingredients of the hip is the people program. What are you doing to inspire your perform collectively? Do you command respect from your peop and ou sensitive to the needs of your troops?

"How are you using the airmen - The airmen's council is for the lower ranking airmen to meet, a colems, and make recommendations to you. It is their instrument to \_\_\_\_\_ir feelings. The higher ranking NCOs and officers must not so of the council, with the exception of the first sergeant. . . . . . . . . the council composed of officers and higher ranking NCOs. to say, you would not have a free and honest discussion -- the who the drain. #### (Con't General Ishimoto Address)

"Let's talk about air technicians for a moment. I have noticed that the same people always receive excellent or outstanding ratings in their annual technician performance report. What about others and why not? I have also noticed that job performance standards in few cases are so low that it is easy to justify outstanding ratings. I know it has hurt individuals receiving outstanding because of low standards established and when required to perform for others, they have failed to live up to expectation. Get involved with your people. Know who are deserving of higher ratings and question his or her supervisor why only a satisfactory rating is recommended. Don't rubber stamp the technician performance report.

"In an effort to enhance the people program, I have asked for several programs to be implemented. One is the special services committee; the others are the HANG Ohana musical group, canoe club, and the community action CPR program. Colonel Lee conceived the idea of the HANG awards banquet. William Tell, load crew competition, JCS exercise, etc.—these are people programs. I am sure you can conceive other programs.

"Another essential ingredient of leadership is loyalty. A great majority of you practice this virtue diligently. Nevertheless, I have heard subordinates make adverse comments of their supervisor or commander. Some examples are this policy is not my idea; it came from above and I can't do anything about it. Or blame it on the commander or higher headquarters. If you practice this kind of negative leadership, I suggest you correct it immediately. There is no place for such negative leadership in the Guard or in the Air Force. Before a policy is rendered, you have your day in court to express your concerns. Once the decision is made by your boss, the conversation ends and you must live up to the policy. However, after abiding by the policy and you find it to be detrimental to your operation, to the welfare of your people or to their morale, then you should state your facts in writing and request for reconsideration Here, I am stressing that you must have facts and that the reconsideration is not based on emotion. A point in case, HANG supplement to ANGR 39-29 which has to do with promotion of airmen, i.e., time in grade restriction, was reduced from six years to five years for promotion to E-5 by the NGB. Our supplement added a restriction by requiring attendance at McGhee Tyson ANGB or comparable correspondence course in leadership training. The reduction from six years to five years was to enhance retention. When we added our requirement, it was counterproductive to the to the retention effort. This matter was brought to my attention by a second lieutenant who had written a fully justified letter stating the problems he had in retention. This is leadership and he showed he really cared for his people. After checking into the problem, I rescinded the supplement.

"All of us must work together and press forward toward attaining a common goal--readiness. We cannot readily attain this if we continue to back bite or undermine the efforts of management. In this regard, I want to state it very clearly that I will not tolerate any disparaging remarks made against my headquarters or any member of my staff or to any commander. My staff is available to help you and I want to assure you that they are not spies.

Examples of how my staff has helped the units are the C-E activity inspections and VCO inspections. Initially, the units did not accept the prograthowever, these inspections have helped the units to eliminate many discrepancies and, as a result, the recent MEI had no writeups in these areas. If you have any heartburns of any individual on my staff, discuss it with me personally and I will resolve it, but I will not tolerate any disparaging remarks. The key word is cooperation. We must pull together.

# COMPTROLLERS GARNER FIRST ANNUAL 154TH COMBAT SUPPORT SQ VOLLEYBALE TOURNEMENT

The Air Training Command plans to reorganize its five technical training centers by Jan. 1, 1978, a move expected to eliminate approximately 374 positions and save the Air Force about \$5 million annually.

The centers are the Air Force Military Training Center at Lackland and Sheppard AFBs, Tex., and the technical training centers at Chanute AFB, Ill., Lowry AFB, Colo., and Keesler AFB, Miss.
