PAYCHECK DELIVERY EXPLAINED

During the month of January 1982, the Air Force Accounting and Finance Center (AFAFC) experienced extensive transmission/computer problems. In an effort to correct these problems, the AFAFC initiated two special computer runs which affected your payments in the following manner:

- a. Normal end-of-month paychecks were not ffected and all SURE-PAY participants had payents deposited. (Checks were dated 29 Jan 82)
 - b. 16 17 Jan 82 UTA payments were processed on the first special computer run and all paychecks were sent directly to members' mailing address regardless of SURE-PAY participation. (This check was also dated 29 Jan 82)
 - (1) February 1982 SGLI premiums was also deducted on this paycheck.
 - (2) If you received payments on this paycheck, no SGLI premium will be deducted during February 1982.

Some members may also receive another paycheck dated 1 Feb 82. This will be the second special computer run and SURE-PAY will also be suppressed for this paycheck.

Please accept our apologies for all the inconveniences and confusions caused by the AFAFC's computer problems.

would also like to advise all SURE-PAY rticipants that whenever AFAFC encounters oblems and processes special computer runs, your paychecks will be sent directly to your mailing address and not be deposited to financial institutions.

The year of the Dog offers an exceedingly challenging and interesting year. Of course, foremost in our agenda for '82 is the PACAF ORI/MEI slated for sometime during the Oct-Nov-Dec time frame. To meet our other training and deployment obligations, we will commence our concentrated ORI/MEI preparation in June with a special look at ourselves and our readiness capability in August when we will have a five day annual training period.

To Keep you abreast of anticipated events:

a. Selected members from the 169 and 150 AC&W Squadrons will be participating Team Spirit '82. They will brave the snow and cold of the Korean front to participate in the largest WESTPAC joint combat exercise.

 b. We will deploy with 89 of our personnel to Nellis AFB, Nevada on 6-20
 March to play in our first Red Flag air war

c. Selected members from the 199 TFS and CAMRON will deploy to Kwajalein to work on a special assigned project.

d. The Civil Engineering Flight (the others) will be leaving in late June for Cheyene, Wyoming for their two week annual training.

e. The Clinic will deploy to Clark
Air Base in July. Besides their deployment,
the Clinic will be liable for their MEI
probably sometime during the summer months.

f. The UTAs for February, May and August will focus on air defense exercise scenarios. With the existing air traffic control constraints, our air defense exercises have been severely limited. We need to optimize the use of the time afforded us by FAA during our training periods.

g. Throughout the year we will be assisting in the OJT and transition training of personnel from other mainland units who will be converting to F-4s.

I've briefly summarized our anticipated major activities for CY 1982. The activities we have selected have been derived under several working assumptions: that the resultant training is challenging and meaningful; that it affords and recognizes options for individuals as well as team growth and that the activity selected, whether it be an exercise or deployment elicit the growth capability of the "whole" person rather than being limited to technical skill development. We are, in effect, looking to develop better people for our community.

FOUR THUNDERBIRDS DIE IN CRASH

Four pilots of the U.S. Air Force Air Demonstration Squadron, the Thunderbirds, were killed January 18 during an aerial demonstration practice mission. The accident involving four T-38 Talons occurred at 10 a.m. Pacific Standard Time at the Indian Springs Auxiliary Station, 40 miles northwest of Nellis AFB. No one on the ground was hurt.

Killed were Major Norman L. Lowry of Radford, Va., Captain Willie Mays of Ripley, Tenn., Captain Joseph N. Peterson of Tuskegee, Ala., and Captain Mark E. Melancon of Dallas.

The Thunderbirds were practicing at the Indian Springs training site for this year's planned 87 shows in the United States, Puerto Rico and Canada.

President Ronald Reagan expressed sadness upon hearing of the tragic accident and joined Secretary of the Air Force Verne Orr and Air Force Chief of Staff Gen. Lew Allen Jr. in extending condolences and their deepest sympathy to the families of the officers as well as to all members of the Thunderbird team.

The Thunderbirds were formed in 1953 to show the capabilities of Air Force aircraft and people and to support Air Force recruiting efforts.

GROUP SAFETY BRIEFS

*AFOSH Standard 161-9 states that Radiofrequency (RF) Hazard warning signs be posted at any location where personnel could be exposed to possible excessive radiation. One such location is the radar nosedock (Bldg 3402), Mauka-Diamond Head side of the hangar. If you are in the area and see the rotating yellow lights on, exercise caution and keep clear of the "fan-shaped" area bordered by read markings on the ground. This radiates 80 feet from the building.

*Imagine the official concern over the campaign to encourage safety-belt use when some of the posters read: "Drivers, belt the wife and kids and keep them safe." They decided that this was a little off the mark. Regardless, the message is clear. It is always a good idea to buckle up and encourage others to do the same. The force of impact at 10 MPH is equivalent to the force catching a 200 pound bag of cement from a first-story window. So, even at "slow" speeds of 35 MPH, the force of the impact on you or your passengers is brutal. There's no way your arms and legs can brace against that kind of collision...think about it.

F A T FACTS.... DR. GALLUP

Not so long ago the ability to store food energy as fat provided significant survival value to animals living amid food scarcity. Western society however, is generally not characterized by periodic food shortage and, as a consequence, the ability to store fat all too frequently becomes of negative survival value because of over-consumption and the resulting obesity. When caloric intake exceeds expenditure of excess calories, we store it as fat. These calories are mobilized at varying rates depending on the calibre of exertion. For example, wal ing at 3.5 miles an hour would use 5 calories a minute, while running could consume 19 calories a minute. Even reclining uses 1.3 calories a minute. Fat provides 9 calories per gram or 4086 calories per pound. To be completely utilized, one pound of fat would require 820 minutes of walking, 215 minutes of running, or 2 days, 4 hours, and 22 minutes of reclining. Exercise ALONE is not the solution to the overweight problem. More next month.

Increased Coverage = SGLT: Public Law 97-66, 17 Oct 81, increased SGLI coverage to a new maximum of \$35,000. Effective 1 Dec 81, all military personnel automatically received maximum coverage. Members desiring reduced or no coverage must complete a new SGLI election. Insurance is only available in \$5000 increments. Premium levels are 75 cents per \$5000 to a maximum of \$5.25 for \$35,000 coverage. DPMA, 449-5669

Point Credit for ECI: During the month of October 1981 we experienced a systems problem. Points earned during this period were not automatically posted. Manual adjustments are being accomplished with the aid of Military Pay. Individuals completing ECI volumes and end of course exams in the August to October period are requested to review their PCARS printout of points earned to determine if reported. DPMA, 449-5669

Automated Security Clearance Approval System (ASCAS): Numerous inquiries concerning security clearances have been addressed to CBPO and assistance is being provided as best as possible IAW AFR 205-32, but be advised that HIANG/CS is the OPR. CBPO's function is to support the system. Please direct future inquiries there. DPMA, 449-5669

Excerpt from NGB message: Unit Vacancy Promotions. At the time the Bureau publishes the special orders announcing Federal Recognition of a unit vacancy promotion, the Personnel Data System (PDS) is updated. Therefore, Federal Recognition is extended at that time. When the CBPO is notified via PDS of Federal Recognition being approved the officer may be permitted to begin wearing the insignia of his/her new grade. Units need not wait until special orders arrive to permit a member to assume a new grade when PDS reflects the higher grade.

Awards and Decorations: AF Form 642 (AFAM/AFCM Justification) is a mandatory item in the Recommendation for Decoration package for AFAM and AFCM based on meritorious service. RIP DECOR I is revised to reflect first and second indorsements from supervisor to unit commander to CBPO Personnel Affairs. Further all recommendation RIPs are changed to include reference to the AFAM.

The Air Force Training Ribbon is awarded upon completion of initial military accession training and is retroactive to 15 Aug 74. Course completion certificate is the required source document for updating the APDS. No more than one ribbon will be awarded to anyone person. No devices are authorized to be placed on the ribbon. It is to be worn immediately following the Small Arms Expert Marksmanship Ribbon. DPMA, 449-5669

official Photographs: Effective 1 Mar 82 a new approach will be implemented IAW AFR 36-93. Individual officers will be responsible for accomplishing their photos. The 5 year requirement has been revised to a required photo upon promotion to First Lieutenant thru Lieutenant Colonel. No further action will be taken by the CBPO once the officer's immediate commander has replied by indorsement to the follow-up RIP that the officer has been advised. DPMA, 449-5669
