
LABOR OF LOVE



Lt Colonel O'Day and Company are in the process of conversion training. Much of the training is back at CONUS technical training schools. Still part of the aircraft control and warning system is the 150 AC&W Squadron under Lt Colonel Owen Ota. The Kokee detachment, while maintaining a manual radar capability will retain an important air defense role.



Spotlight on the Top

Lt Col Cedric D. O. Chong was born in Honolulu, HI on 3 September 1938. He graduated from Roosevelt High School (Class of '56). After attending Oregon State University and the University of Hawaii, Lt Col Chong earned his B. S. degree in general engineering in 1962. (His minors were in electrical and mechanical engineering).

Lt Col Chong was commissioned a second lieutenant through the ROTC. He attended primary training at Chanute Air Force Base, Illinois as a Vehicle Maintenance Officer in 1962. and remained there on active duty until 1965. After his military discharge, he was employed by Pacific Marine and later, Oahu Air Conditioning Co. as a mechanical and electrical engineer. Lt Col Chong joined the HANG, 169 AC&W Sq and accepted a full-time position as Base Civil Engineer. In 1974, he was appointed as the Contracting and Engineering Officer for the Dept of Defense, State of Hawaii, responsible for all Army National Guard, Air National Guard and Civil Defense real property, facility planning, construction, operations, maintenance and repairs. Lt Col Chong has been commander of the 154 Civil Engineering Flight since 1973. The unit includes 70 authorized personnel. Lt Col Chong achieved the rank of Lt

Col in 1981.

He is licensed in both the Mechanical and Electrical Engineering fields and currently manages his own engineering firm which was founded in 1976.

Lt Col Chong enjoys playing tennis and fishing. He is married to the former Barbara Meyer of Louisville, Kentucky, They have four sons: Cedric Jr., James, Michael and Robert.

AFOS WILL CHALLENGE TRAVEL CLAIMS UNDER FWA.

The Air Force Accounting and Finance Offices (AFOs) will play a larger role in challenging doubtful or suspicious travel claims to detect fraud, waste, and abuse (FWA).

That determination was made during March 1983 when the Director of Fraud Investigation met with AFAFC officials. It was spurred by the Air Force Office of Special Investigation (AFOSI) which recently completed an investigation of travel voucher fraud.

AFOs will use the following procedures to ensure that claims are reasonable:

a. Refer any doubtful or suspicious claims back to the traveler for additional justification or information for any large costs incurred.

b. When justification and information is not satisfactory, refer the claim to the traveler's commander for review and discussion. The commander must certify the reasonableness of claim for payment. Obtaining additional justification from a claimant to support a doubtful or suspicious claim not only assists the AFO in determining reasonableness, but provides an audit trail later for investigation if it is needed.

c. If this doesn't prove satisfactory, deny payment for that portion of the claim suspected and the information obtained from the commander provides derogatory information, such as where meals were obtained and places where lodging were secured,

AFOs may refer the case to the AFOSI for investigation.

Kimura Honored

On Aug. 18, Governor George R. Ariyoshi presented official commendations to four Hawaii public school teachers for their achievements in science and mathmatics teaching.

The four high school teachers were nominated and selected by their peers to represent Hawaii as finalists in the national Presidential Awards for Excellence in Science and Mathmatics Teaching Program.

Arthur Kimura of Mckinley High School, a biology teacher was one of the nominees for the science teaching award. Kimura is a drill status Major assigned to the 169th ACW SQ. as an air weapons controller. Kimura's service to HANG has been invaluable. He was selected as the outstanding AWC in HANG during 1980. Kimura participated in the last two Team Spirit exercises in Korea (1982/83) and has received letters of commendation from the commanders of the units he worked with for his outstanding performance. Because of his expertise, Kimura was personally asked by the PACAF IG Team Chief to augment the IG Team in an ORI/MEI no-notice inspection of regular Air Force units in West Pac.

For the past 10 years Kimura has taught biology and has been especially successful in applying the classroom to real life situations in biology. His zoo instructors program enables students to receive practical experience in dealing with animals that cannot be provided otherwise. He has also contributed time and expertise as a coach and advisor to student and community groups. Four state awards were chosen from each of the 50 states, Washington, D.C. and Puerto Rico. From these 208 awards, 104 Presidential Award winners will be selected. They will be honored at an awards ceremony in Washington, D.C., and the teachers will receive for their schools a \$5,000 grant from the National Science Foundation to supplement the school's support of mathmatics or science teaching.



Over the next few weeks you will see what was once the Avionics Shop's temporary home transformed into a major gathering center for members of HANG statewide. The building itself is 150 feet long and 20 feet wide offering some 3,000 square feed of interior space. There will be 20 bunks in the men's quarters and a separate room with 4 bunks for wahines. Separate latrine facilities are now being installed complete with showers. There will be a large lounge on the Ewa side of the building and a religious activities room located near the living quarters which could double as a dayroom for overnight guests. First priority usage will be given to personnel in direct support of the HANG mission. "What we're trying to provide is in-

formal billets for Guard members who are here on Oahu or visiting from the neighbor islands...The charter will be circulated soon to all unit commanders explaining all the specifics about the purpose of the Center and specifics about what it can be used for."

The Center is strategically located right next to the Composite Athletic Field's third base line. That's especially convenient because of the huge sun deck on the front of the building. The deck runs the entire length of the Center and is about 16 feet wide, offering a great view of the playing field and easy access to the lounge area. Future plans call for portions of the deck to be covered so there will be a cool shady spot where spectators can sit and watch a game and sip a cool soda or two, Correa says.

One of the biggest stumblin blocks was providing utility services to the area. "We started back in Oct- (ober of last year," Correa explained. "There was no electricity, water, sew age or anything else out to that area.

That was our first concern, because r guys were out there working with _enerators. It took us about six months with just drill weekends to get the job done." But with a lot of hard work and creative application of effort, Correa and his team began to see the project really taking form. He says the going was really tough at first, but after laying hundreds of yards of underground water, sewage and electrical lines, the Center be-gan to come to life.

"Take MSgt Moses Timbal, for example," Correa says, "he did just about all of the electrical work. We were standing out on the ball field one afternoon looking at the place, and I just casually commented how nice it would be to have some luau lights to go in the trees that stand in front of the building. We had the lights already, you know the strings 40-watt bulbs. The next mornng, I came out and Moses has all the "inderground conduits already in

ce. It was amazing, But then ings like that happen around here."

Plumbing was a potential problem too. A special pump had to be constructed to connect the Center's waste removal lines into the main system. "Tivera was responsible for all the plumbing," Correa said of TSgt Elpidio Tivera. "He's really worked hard. There are so many people who have contributed. Joe Kaaikaula was in charge of all our purchasing and ordering. And, Dale Kuni and Henry Hasuike (of CAMRON Avionics) have made major contributions of effort. These are the kind of guys you tell to go find an aircraft carrier and the first thing they say is what color?"

The next major project to complete the Center is landscaping. "We're still going to need a lot of Unteer help on seeding the area. We got 300 pounds of seed just waiting to go into the ground. May-

mission requirements and training as top priorities. Beyond the mission HANG members may use the complex for recreational purposes and in support of community projects."Say a unit wants the place for the weekend, or say a HANG member's family or boy scout troop wants to use the place for a day. As long as they take care of the place, it will be available. People are going to have to treat this place like their own home. Clean up when you're pau and take care of the equipment, and there's no end to the potential use by Guard members."

"It's really been a labor of love for us. And, we can always use more help or contributions like plants or trees." Correa says the Center is about 80% complete and could be ready for operation soon. "We've got lots of ideas and plans for future improvements. We don't have a lot of money to spend, but there are always ways to get around that if you've got guys that are dedicated. We've found, the impossible jobs just take take a little longer, that's all."


SHOT SCHEDULE

Since the July UTA the 154 USAF Clinic has changed its hours of operation for immunizations. The Clinic is handling immunizations throughout the day, 8:00 a.m. to 3:00 p.m., on both Saturday and Sunday. Yellow Fever vaccinations are done from 8:00 - 9:00 a.m. on both UTA days. These changes are an experiment to better accommodate HANG members to update their immunizations. Statistics are being maintained to see if this change will be made permanent.

Additionally, the flu immunization program is tentatively scheduled to begin with the October UTA. As in the past, the program will be geared to extend through the February 1984 UTA. The flu immunization is mandatory for all HANG personnel.

So take advantage of this change in hours of operation to make sure your immunizations are current. Keep in mind immunizations have to be current for Team Spirit 1984 and other deployments.

Hawaii Air National Guard does good again! On August 7, 1983, a NRA approved high power rifle match was conducted at USMC Camp Smith Training Facility at Puuloa Firing Range, Ewa Beach, Oahu.

Four HANG shooters competed and the results are as follows:

1. <u>MSgt Myles Brown</u>, 201 CMBTCF (Maui), won first place in the Master Class with a score of 455-4X. He also placed second in the 600 yard prone stage (189-4X).

3. <u>SSgt Norman Tyau</u>, 154 CAMRON, won first place in the Marksman Class with a score of 435-5X.

4. <u>TSgt Eric Kanazawa</u>, 154 CAMRON, placed first in the 200 yard sitting stage with a score of 96-2X.

During the week of 5-9 Sep, six HANG members on the Hawaii National Guard State Rifle Team (composed of Army and Air Guard) competed in the Thirteenth Annual National Guard Winston P. Wilson Rifle Championship match at Little Rock, Arkansas. The match is named in honor of Major General Winston P. Wilson who strongly supported the markmanship program of the National Guard during his tenure as Chief of the National Guard Bureau.


