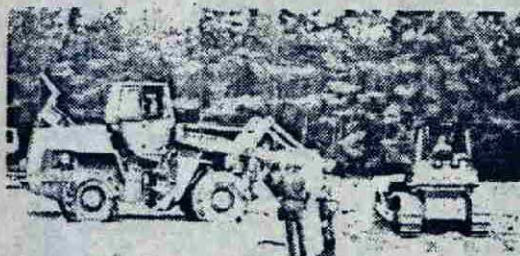

"FIND THE BEEF"

May 30, 1985 marked the beginning of another Air National Guard milestone as 35 members of the 154th Civil Engineering (CE) Flight's Prime BEEF (Base Engineer Emergency Force) team departed for the Pacific Air Force (PACAF) special combat engineering training site at Kunsan Air Base, Korea. This was the first time Air Guard engineers integrated with regular Air Force Prime BEEFers for the specialized wartime training at the camp. During the rigorous five days of training, the 154th worked alongside 40 engineers from Misawa Air base Japan's 432nd Civil Engineering Squadron (PACAF). The site is operated by PACAF's 554th Red Horse Squadron and manned by cadre instructors who are highly experienced heavy equipment operators specially trained in base recovery after attack techniques.

The primary operational tasking of every USAF, ANG and AFRes Civil Engineering Prime BEEF unit is to provide specially skill man- and trained, fully equipped, rapid mobile engineering teams which can deploy to any war zone worldwide withing 28 hours notice. On arrival, teams must rapidly setup living, messing and sanitation facilities then restore enemy bombed runways and taxiways to minimum operating condition so mission aircraft can

TACTICAL HOSPITAL IN JAPAN

Col. John S. W. Lee, 154 Composite Group Commander, said farewell to 44 members of the 154 Tactical Hospital at Hickam's MAC terminal. Hospital workers deployed on their second trip to the USAF Hospital at Yokota Air Base, Japan. This deployment, from June 21 to July 4 involved 38 medical personnel and additional support personnel which included one officer, three cooks, two drivers, one historian and totalled 45 personnel.

The purpose of the deployment was to train with respective counterparts in the medical field and to conduct the Tactical Hospital's medical readiness.

During the 14-day trip, all 154 Tactical Hospital personnel were certified or requalified in the following training areas: 1) Cardiopulmonary Resuscitation, 2) First Aid, 3) Chemical Warfare, 4) Gas Mask Familiarization, 5) Quality Assurance Program, 6) Physical Fitness Testing and 7) Disaster Training.

SAFETY NOTES

CARRYING FLAMMABLES CAN BE HAZARDOUS

A recent fatal POW mishap involving a PACAF member indicated that he was carrying a container of extra gasoline in his car. In a collision, the cap of the container came off and vapors filled the passenger compartment which was ignited by a small fire in the engine area. Both vehicles were engulfed in flames within two minutes of the impact. Other factors in case i.e. alcohol use and non-use of seatbelts. Compound this with extra flammables in the vehicles and you have a "NO-WIN" situation.

VW Bugs have a unique design that is ripe for this type of mishap. The heater ducts which is built into the framepan connects the hot engine directly to the passenger compartment. So if any flammable vapors are in the car, it creates an explosive situation. As a Honolulu Police Traffic Investigator, I've personally investigated a case like this locally and needless to say the operator expired from burns and not injuries from the collision. We hope this information is a lesson learn for all. Let's not make the same mistake.

NEW GI BILL

On July 1, 1985, Public Law 98-525 became effective for all military personnel who meet eligibility requirements. Members, including bonus program participants are eligible for this new educational assistance entitlement. As a result of the new GI Bill, new enlistees will no longer have the option to select between a cash bonus or educational assistance bonus. The educational assistance bonus has been eliminated. Cash enlistment; reenlistment; affiliation bonuses and the Student Loan Repayment Program have not been affected.

A recent ruling by the State Attorney General states that the HNG Tuition Waiver program and the new "GI Bill" cannot both be utilized. Opinion is that it's one or the other.

Eligibility for the new GI Bill is as follows:

- A. Must be a High School diploma graduate or will receive a secondary school diploma or equivalency certificate before completion of initial Active Duty Training (IADT).
- B. Must complete IADT and 180 calendar days satisfactory Selected Reserve service.
- C. Must not have received a baccalaureate degree, or equivalent, or completed a course of instruction required for award of a BA/BS degree.
- D. Must agree to serve 6 years in the Selected Reserve between Jul. 1, 1985 - Jun. 30, 1988.
- E. Officers without degrees must serve 6 years in addition to any other Selected Reserve obligation.

If you meet the above eligibility requirements, you are entitled to receive the new GI Bill benefits. Enrollment may be accomplished at CBPO where DD Form 2385 and necessary extension/reenlistment will be completed. You may execute an immediate reenlistment or extension for a period which, when added to your current obligated service, equals or exceeds 6 years. You must consider

possible ineligibility for reenlistment bonus if you execute an immediate reenlistment or extension prior to your normal Expiration Term of Service (ETS).

Once you are enrolled, it is your responsibility to apply to the VA for benefits. Apply at your local VA office or educational institution's veterans' affairs office.

Benefits are provided for pursuit of a program of education at an institution of higher learning approved by the Veterans Administration (VA). The program will be administered and benefits paid by the VA as follows:

- A. \$140 per month for full-time enrollment.
- B. \$105 per month for three-quarter-time enrollment.
- C. \$70 per month for one-half-time enrollment.

The maximum benefit period is 36 months or the equivalent in three-quarter or one-half time enrollment. School attendance criteria to qualify will be determined by the VA.

Members currently utilizing the Vietnam Era Bill or the VEAP Program are not eligible for the new GI Bill. Like the Tuition Waiver, you cannot double dip. Should you have any questions on the new GI Bill or any other bonus program, contact MSgt. Iris Kabazawa, BCA, at 449-5669 or 449-5685.

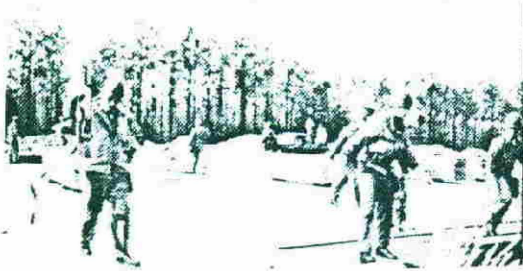

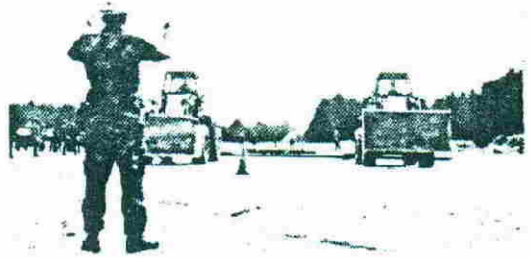
be launched. The next phase of the team's job is to reconstitute primary base support facilities, especially aircraft maintenance, command operating locations and utility systems.



The first day was busy as the team members, working under the direction of 154th deployment OIC, Capt Alvin Satogata and assisted by Capt Sid Keliipueole and Roy Tamashiro, constructed 13 hard and soft back tents for sleeping quarters, messing and sanitation facilities using WRM and Harvest Eagle kits identical to those prepositioned at all USAF theater bases in Korea and Europe. For the next two days, the engineers received instruction and hands-on training in expedient Rapid Runway Repair (RRR), airfield lighting systems, emergency power production, potable water plant assembly and use and short cut methods for building structural repair and utility system restoration. Practical training and field exercises were also given in explosive ordnance recognition and working in chemical warfare environments.



Before dawn on the fourth day, an all day wartime exercise began. As attack warning sirens sounded, the engineers donned gas masks and scrambled to shelters. Once the all clear sounded, field reconnaissance teams selected minimum operating strip locations from cratered runways and taxiways while the RRR teams began moving equipment and materials to command post directed locations. Within four hours, unexploded ordnance was cleared, major craters filled and AM-2 aluminum matting patches assembled and pulled into place over the filled craters. The thumbs up to launch aircraft was given less than four hours after attack.



Cadre evaluators rated 154th performance outstanding in all areas. Just as the rest of the unit had been at Eglin AFB six months earlier. Forty five other 154th members participated in a similar first ever ANG/USAF integrated Prim BEEF training deployment with Hickam's 15 CE Squadron (PACAF) to the Air Force's Special Training Center at Eglin AFB, Florida last December. Through the combination of intense home station training and the two deployments, the 154th attained mission capable Prime BEEF trained status within the first nine months of receiving it's directed operational tasking. This major qualification milestone normally requires at least three years to achieve.



Unit commander, Maj. Jeff Smith, explained the 154th's role and outstanding performance in these words: "Wartime engineering is our first order of business; our job is to fix the runway so the planes can get back in the air fast. Obviously, all the variations that occur in wartime can't be taught academically; our success at solving wartime problems is the combined result of intense home station training, the exceptional initiative of each member of our unit and the pride we take in getting every job done fast and well. What makes all this happen though, are the unequalled leadership qualities and broad experience of our officers and NCOs. Simply put, they're the best I've seen and worked with anywhere!"

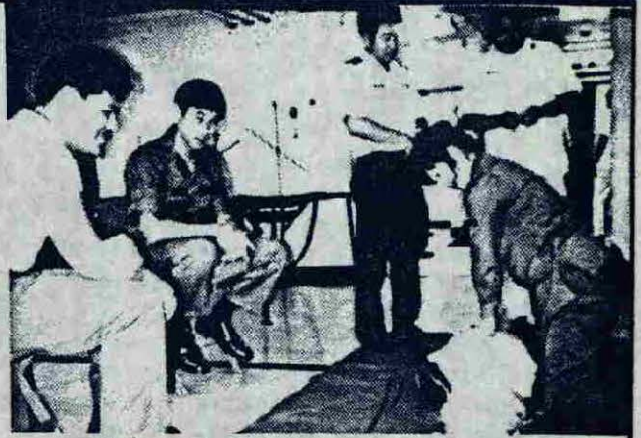

NGAUS KUDOS

Seven units of the Hawaii Air National Guard will be honored at the National Guard Association of the United States (NGAUS) convention to be held in Louisville, Kentucky, 23-25 September 1985, with the presentation of 10 awards.

The 154th Composite Group, Hickam, will be presented with a Distinguished Flying Unit Plaque by the NGAUS and the National Safety Council's highest safety award (Award of Honor) by the Safety Council. The NGAUS annually presents five distinguished flying unit plaques nationwide to recognize units who have shown excellence in achievement, dedication and service to the mission of the Air National Guard. The composite group is the only Hawaii based Air National Guard unit to be awarded the Award of Honor and it is the second time that they have been selected for this award.

The 202nd Combat Communication Flight, Hickam, and the 169th Aircraft Control & Warning Squadron, Wheeler, have both been selected to receive the Mission Support Plaque from the NGAUS, which is presented to outstanding Air National Guard mission support units. Only five plaques are presented annually to Air National Guard units. In addition, both units have again been selected to receive the Award of Commendation from the National Safety Council for their outstanding safety record.

The Award of Commendation will also be presented, by the National Safety Council, to the 150th Aircraft Control & Warning Squadron, Kekaha; 201st CISS (Combat Information Systems Squadron), Hilo; 201st Combat Information Systems Group, Hickam; and 201st CISF (Combat Information Systems Flight), Hickam.

ON TARGET WITH HANG

The fifth annual HANG precision air rifle pistol tournament will be held during the month of November. The tournament will be conducted as follows:

A. Authorized entries: Current members of HANG and personnel in the Air Force Senior Advisors office.

B. Team Composition: Unit team will consist of a minimum of four (4) firing members. When more than four members are on the team, all may fire, but only the four highest scores will be used.

C. Pellet air rifles (single shot) of .177 or .22 caliber that operate by single pump, multiple pump or CO₂'s may be used. The Walther, Feinwerkbau and other air rifles used in international competition are not allowed.

D. Course of fire:

- 1) Distance will be 10 meters (33'Ft)
- 2) 20 shots prone position
- 3) 20 shots standing position
- 4) Time limit of 40 minutes is allowed for each position.

E. Tournament will consist of highest unit team and individual scores (1st, 2nd and 3rd place).

F. Entry date: All entry forms will be NLT Sept. 30, 1985. Entry forms may be locally reproduced.

G. Tournament period: To be completed by Nov. 30th and all targets returned NLT Dec. 8th.

BELLOWS AFS FACILITIES

A few of our HANG personnel were turned away from using the Bellows AFS facilities, including AGR-types applying for cabins. Has there been a policy change for the summer period which precludes or restricts ANG personnel from using facilities at Bellows?

The following applies:

A. Reservists on active duty and AGR personnel are entitled to use the Bellows AFS facilities at any time.

B. Active duty is defined as periods of "72 hours or more" on orders.

C. While making reservations, a person

need not be on active duty; however, you must be on active duty during the period you are actually using the facilities.

D. They will not accept any reservations more than thirty (30) days in advance of the requested (start) date; i.e., requested date is Aug. 30, 1985 application must be made on Jul. 31, 1985 and no earlier.

E. For weekend reservations, check-in time is by COB Friday - there will be no check-ins on Saturdays or Sundays.

F. The only "new" policy change (made during the last year) is that all ANG/Reservists must be on active duty when using the facilities - camp sites, cabins, picnic areas, etc. Previously, use was unrestricted but on a "spaceavailable" basis; individual did not have to be on active duty.

The key to remember is to tell the reservations clerk that you are, or at least will be, on active duty during the period of use. Just advising them that you are in the Hawaii ANG, Air Guard, AGR, or a Reservist, could lead to a quick misunderstanding or evoke a denial of entitlement response. Everyone should remember that the use of Bellows AFS is a privilege and not a right.

Participation is limited to 12 teams as only 12 lanes will be available.

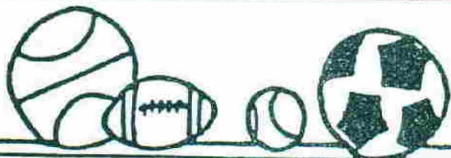
This will be a two day event, with the team event on one day and the singles and doubles on the other.

Bowling establishments being considered are Aiea, MAK or Classic.

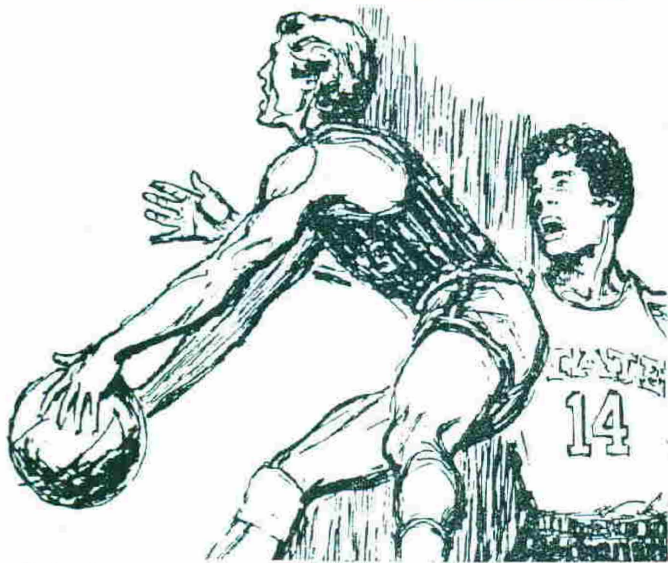
Approximate time is 3 hours for the team and 2½ hours for the singles and doubles (each).
