PORTLAND DEPLOYMENT

Forty members of the 154 Combat Support Squadron, 154 Security Police Flight and the 150 AC&W Security Police unit deployed to the Portland ANG for 12 days of cross-training from Feb. 14-25. The deployment was hosted by the 142 FIG and provided excellent cross-training experiences in the CBPO, food services, administration, training, security police, photo lab and transportation.

Hawaii Guard members worked side-by-side with their functional counterparts in accomplishing the daily 142 FIG work. They were able to learn how to operate new machinery and adopt to a new operating environment. Close working relations were developed resulting in evenings shared with Portland ANG families.

Aside from working hard, our Hawaii contingent was treated, on the weekends, to tours through the Columbia River Gorge, Mt. Hood, Timberline Ski Resort (training site of the USA Olympic Ski Team) and the northern Oregon coastline.

The Columbia River Gorge tour included a visit to a salmon hatchery operated by the state of Oregon. Thousands of salmon fingerlings are born at the hatchery, raised and released into the Columbia River to improve the quality of sports and commercial fishing. The salmon's unique ability to mature in the Pacific Ocean and return and spawn in the river encourages state and commercial salmon hatcheries.

Another Columbia River highlight was a trip to the Bonneville Dam hydro-electric facility where visitors saw salmon fish ladders and the operation of a lock.

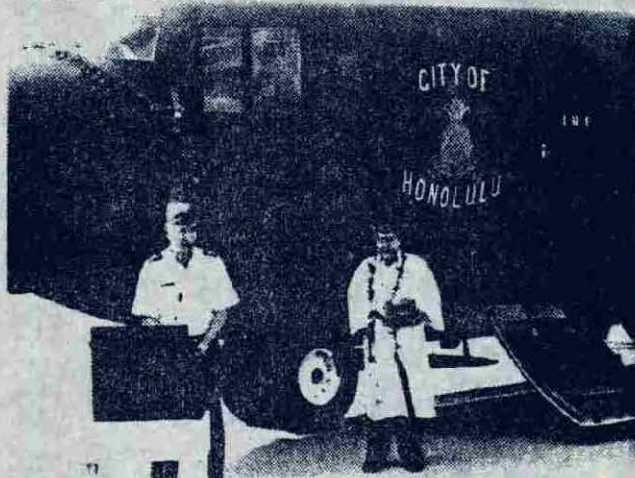
The Multnomah Falls was a breathtaking treat. For many HANG folks it was their first experience with snow and black ice.

The Oregon Museum of Science and Industry offered hands-on computer based gravitational, static electricity, geometric and mathematical relationship and medical displays. Members also visited the Oregon Zoo.

The Hawaii Code of Military Justice came into force on February 11, 1985; it applies to all Hawaii National Guard personnel in a State Duty Status. The Code deals with Military offenses which hinders the promotion of good order and discipline. Throughout this year, all HANG personnel will be educated as to the intent and implications of this Code.

This Code has been mandated to promote military justice and will not be used as substitute for positive leadership and responsible management. In our effort to maintain a quality force, the significance of discipline has played an active role in setting our standards of command. We, in effect, have set the requirement to live by a set of rules which govern our conduct. The Code serves as a tool to the Commander to maintain respect for the established rules of military life; if punishment must be utilized, the Code defines the limits of prosperity and fairness in administering punishment.

We will continue to handle the resolution of problems through our "tried and tested" methods. Professional leadership especially through knowledgeable and fair NCO supervision remains the keystone of our military justice system. Errors in personnel disciplinary action at the first line of supervision have the adjudicating benefit of upper level review to insure a pervasive emphasis on justice for the individual. Being firm and fair is supportive of recognizing the priority we place on our mission and our personnel interests.

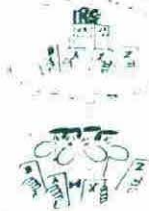

Secretary Orr Defends

Retirement System

WASHINGTON (AFNS) - "It's not lavish. It's a management tool we need," stressed Secretary of the Air Force Verne Orr. His statements are a retort to recent attacks on the military retirement system. Secretary Orr defended retirement pay, Feb. 7, in an interview with Air Force Radio News Service. He was reacting to charges made two days earlier by David A. Stockman, Director of the Office of Management and Budget.

Mr. Stockman asked Congress to reduce military retirement pay, calling it a "scandal" and an "outrage." He also said Pentagon institutional forces are more concerned about protecting their pay than the defense of the country.

Referring to Mr. Stockman's charges, Secretary Orr said, "Well, they hurt. And I think they were ill-advised and ill-informed.

"The public has a great misconception of the retirement system," he said. The Secretary says he visits about one base per week and "The number one question raised on every base, every time, is about retirement."

And that doesn't come, as Mr. Stockman seemed to indicate, from Generals in the Pentagon protecting their own retirement. That comes from our airmen and NCOs out there on the bases who are concerned about all the talk," he continued.

"The average person does not retire with 50 percent of his pay. In the first place, the average person does not retire--only 13 percent of those who enter the military use the retirement system.

"They talk about it being 50 percent of pay," he said. "But we all know retirement is computed only on base pay and does not include allowances such as housing and subsistence. Now let's get it straight."

Secretary Orr expects other attacks on the retirement system, but was encouraged by what Rep. William L. Dickinson, R-Ala., told him. Rep. Dickinson, ranking minority member of the House Armed Services Committee, told the Secretary that he knows of no intention to change the retirement system for people now on active duty. (AFNS)

Hawaii Code of Military Justice

The Hawaii Code of Military Justice was recently adopted and is effective as of February 11, 1985. The scope of the Hawaii code includes military justice for Hawaii National Guard personnel as applied to military offenses. Throughout 1985 all HANG personnel will be briefed as to the implications of this new code. Training for military supervisors will also be part of the inception of the code.

To understand the intent in the applications of the Hawaii Code of Military Justice, the General guidance statement from the Code is extracted:

"Military Justice is not and shall not be used as a substitute for military leadership. Providing military leadership remain the responsibility of all officers and non-commissioned officers of the State Military forces. Guidance and counseling shall be given to any member of the State Military forces by the member's chain of command at the first sign of a disciplinary problem. The commanding officer of each unit shall establish informal procedures to deal with disciplinary problems. . . If the use of informal procedures fails to resolve the member's disciplinary problem, the Hawaii Code of Military Justice may be used."

We are currently arranging for a presentation of the Code during the April ancillary training period.

DD Form 1853

Effective January 1, 1985, the only valid edition of DD Form 1853, "Authentication of Reserve Status for Travel Eligibility," is the form dated April 1, 1984. The previous editions of the form will no longer be accepted at passenger terminals. This is in accordance with IMC 84-1 DOD 4515.13R, Paragraph 2-12c.

Post and base exchanges are now operating under the provisions of paragraph 2-14b (4)(c), AR 60-20/AFR 147-14, dated August 1984. The regulation requires that exchange privileges must be used within 6 months from the date the entitlement was earned, as shown in either the Military Leave and Earnings Statement or Letter of Authorization.
