NEW NATIONAL GUARD ACCIDENT INSURANCE

The Saint Paul Fire and Marine Company, through the Home Insurance Company is again offering accident coverage for Guard officers and airmen. Coverage is available for both drill status and full time personnel. The premium is \$5.00 per year for officers and airmen on drill status and \$10.00 a year for full time employees.

Coverage includes an accidental death benefit payment of \$3,000.00; a weekly income replacement benefit of \$30.00 per week; and medical expenses up to \$300.00.

According to Capt. Norman T. Westly, Transportation Officer, drill status people are covered from the time they leave home until they return. Air Technicians are covered the entire year. Westly also mentioned that the company will pay-off regardless of any other coverage you may have.

If interested, sign up at Headquarters anytime before summer camp.

# GENERAL NEWS

## TRAFFIC REMINDERS

Capt Carl Thoene, Fighter Squadron Adjutant, urges personnel to slow down on their driving and observe stop signs, traffic signals, etc., while driving on base. Too many of our personnel are receiving citations, he said.

Capt Thoene mentioned that a point system is now in effect at Hickam. Points are assessed for various traffic violations. Under this system, your on-base driving privileges can be revoked.

Airmen and officers are responsible to notify 6486th Air Police Squadron when they sell their vehicle, renewal of insurance, changing color paint job on their auto. This must be done as soon as possible and not later than 72 hours after such changes.

### Notify Hickam AP

Officers and NCOs are authorized to telephone and inform the AP Squadron of such changes. Airmen, grades E-1 to E-4, must report personally and furnish necessary proof of such changes.

## RED CAPS

According to LtCol Walter F. Judd, Support Sq Comdr, all airmen in the Support Squadron will be required to wear red caps instead of the fatigue caps as part of the official work uniform within the Squadron area.

The woolen caps, which resemble a baseball cap, have the Squadron's motto "Kokua" sewn on the back. When available, the Squadron insignia will be put on the front.

Col Judd said money to purchase the red caps will be obtained from the Squadron Fund. Aircraft Maintenance,

Unit Supply, and Photo Lab Sections are scheduled to receive the red caps. The remainder of the Squadron will receive their caps later.
