#### WARNING ON HATCHBACK AUTOMOBILES

The following is a reprint of an article that appeared in the October 30, 1978 issue of the Air Force times and is provided for the information of all concerned:

"The Department of Transporatation warns owners of hatchbacks about the dangers of driving with children riding in the luggage compartment. It also is advising owners to keep the hatchback closed whenever the engine is running, i.e., this is to prevent entry of carbon monoxide into the passenger compartment.

"The warning came in a consumer advisory issued by the department's National Highway Traffic Safety Administration.

"Joan Claybrook, Director of NHTSA, said that the agency received reports of motorist driving with the hatchback in the up position, often with young children riding in the rear of the vehicle. This is exceedingly dangerous, she said, and creates a risk of serious injury in relatively minor accidents. NHTSA reports 12 accidents in which passengers were ejected through the rear hatchback, resulting in five (5) fatalities."

### MOTORCYCLE CRASHES. VISIBILITY THE PROBLEM

WASHINGTON (AFNS) -- Failure of drivers to see motorcycles in traffic is the major cause of motorcycle accidents, according to preliminary findings of a U.S. Department of Transportation study.

In some 51 percent of motorcycle accidents studied in the Los Angeles area over the last  $2^{i_2}$  years, motorists said they either did not see the motorcyclist or saw the rider only after it was too late. Also, a motorist turning left across the path of the cyclist was seen in some 45 percent of all accidents.

I congratulate you on the highly successful deployment of your 199th Tactical Fighter Squadron to Clark AB for participation in the COMBAT SAGE Weapons System Evaluation Program (WSEP).

Your aircraft were in excellent condition. Also, the performance of your aircrews and support personnel under the leadership of Lt Colonel Lawrence Cabrinha, Detachment Commander, and Chief Master Sergeant Hiroshi Go, Maintenance NCOIC, was exemplary. Singled out for commendation by 3TFW personnel, who had the pleasure of working with the HANG, was your Air Force Senior Enlisted Advisor, Master Sergeant Donald Johnson.

The COMBAT SAGE program is normally a unidirectional training and evaluation process from the 1st Test Squadron to the hosted unit. In the case of the HANG deployment, the process was two way. #### H.N.G.E.A. NEWS

ENLISTED RETIREMENT: Two bills relating to Reserve retirement died with the 95th Congress. The first, H.R.10341 which passed the House, would have permitted enlisted Reservists with 20 years of Active federal military service to draw retired pay immediate ly without waiting to age 60. Passage of the bill would have put Air beservists on a par with Naval and Marine Corps Reservists who presently enjoy this entitlement. The other bill which failed to pass, H.R. 10340, would have allowed certain otherwise eligible Reservists (who never served on Active duty during periods of war) to draw retired pay.

SURVIVOR BENEFITS: Amendments to the survivor benifit plan were signed into law by the President on September 30, 1978. These amendments provide eligibility for annuity for the surviving spouse of a Reservist who dies before receipt of retired pay at age 60. Cost of living increases were also authorized for those receiving annuities under the old Retired Servicemen's Family Protection Plan, and reinstatement of benifits is now authorized for surviving spouses who remarry after age 60. An SBP amendment which did not pass proposed that the Social Security offset in the SBP be reduced from 100 per cent to 50 per cent.
