Refuse Collection and Disposal Services for the Hawaii Air National Guard at
Joint Base Pearl Harbor-Hickam and Kalaeloa, State of Hawaii, Department of Defense,
Hawaii Air National Guard, Job No. CA-202114

SPECIAL INSTRUCTIONS:

BID ITEM #1:

- Furnish (3) 3 cubic yard bins
 - Wheels required for 3 CY
 - Bins need to be painted "Brown"
- Furnish (11) 6 cubic yard bins
 - Wheels not required for 6 CY
 - Bins need to be painted "Brown"
- Furnish (3) 30 cubic yard bins (1) for metal (M), (1) cardboard (CB), (1) for wood (W)
 - Location of the 30 cubic yard bins may change to other HIANG facilities at JBPHH. Customer will inform vendor of a new location, no later than 10 working days prior to the next scheduled pickup. Request dumping on **Tuesday or Wednesday** NET 0700 and must dump prior NLT 1530.
- Bin locations are as follows:

BID ITEM #2:

- Furnish one (1) 3 cubic yard bin to Kalaeloa, Hawaii Air National Guard. Collection is to be twice a month on Tuesday or Wednesday. Request a separate invoice for this location.

Provide monthly reports total tonnage removed from all 30 CY containers in accordance to this statement of work

NOTE:

- Containers must be easily accessible by one individual.
- Containers must be uniform in configuration and appearance and easily recognized as a refuse container.
- All containers must be painted the same color (brown) with repainting done annually or as requested.
- All containers must be maintained for the safety of the users.
- Allow on-call dumping service with 24-hour notice per dumpster and per facility location based on customer needs.
- Allow adjustment of dumpster size and/or location to be adjusted with 10 day notice from the customer
- Require monthly tonnage reports for the 30-CY bins
- Request 30 CY dumpsters be taken to locations where the customer is not charged a fee for dumping.
- Request 30 CY dumpsters dump cycle be pre-coordinated with customer 48 hours prior to pick and dumping.
