The Hawai'i Emergency Management Agency (HI-EMA) was awarded the FY 2021 Regional Catastrophic Preparedness Grant (RCPG) by the Department of Homeland Security (DHS). The purpose of this project is to build and enhance Hawai'i's local and regional logistics response capacity, thus reducing its reliance on Federal assistance. To do this, HI-EMA's goals are to assemble a Logistics and Supply Chain Management Working Group with key partners around the State and to develop and finalize a written plan.
