POSITION: Fighter Pilot, F-22, AFSC 11F3J (F-22 ACA Pilot, POSNR 0963109, SPMD FK6R). Unit of assignment: 199th Fighter Squadron, Hawaii Air National Guard, Hawaii (HIANG) (To establish a List of Eligible)

TYPE OF APPOINTMENT: Full-Time Military Duty (Title 32, USC 502(f)) – One (1) to Five (5) year tour length (**See NOTES TO APPLICANTS**)

LOCATION: Joint Base Pearl Harbor-Hickam, Hawaii

CLOSING DATE: 3 August 2018

RECRUITMENT AREA: Present commissioned officers 1LT (O-2) to Maj (O-4) of the US Armed Forces Nationwide.

SUMMARY OF DUTIES:

- Plans and prepares for mission. Reviews mission tasking, intelligence, and weather information. Supervises mission planning, preparation and filing of flight plan, and crew briefing. Ensures aircraft is preflighted, inspected, loaded, equipped, and manned for mission.
- Pilots aircraft and commands crew. Operates aircraft controls and equipment. Performs, supervises, or directs navigation, in-flight refueling (except Q Suffix, IFF (AT-38/T-38C)), and weapons delivery.
- Conducts or supervises training of crewmembers. Ensures operational readiness of crew by conducting or supervising mission specific training.
- Develops plans and policies, monitors operations, and advises commanders. Assists commanders and performs staff functions related to this specialty.

Must pass standardization/evaluation flight examinations and meet annual flying requirements as prescribed by applicable regulations and directives and performs other duties as assigned.

ADDITIONAL QUALIFICATIONS REQUIRED: Must be a rated pilot on flying status. The following documents must be submitted to validate experience:

- Individual Flight Records/flying history
- Aeronautical orders

- Evidence of Airplane Pilot Rating
- Evidence of current Class II physical
- Must be current and qualified in the F-22 MDS.

Per ANGI 36-101, paragraph 5.2. The intent of the AGR program is to assess AFSC qualified individuals. Applicants must possess AFSC 11F3J.

Must have a current Single Scope Background Investigation (SSBI).
