
### New Veterans' Services Counselors on Oahu



### **50th Anniversary Vietnam War Commemoration Seal**

#### **ABOUT THE SEAL**

Description of The United States of America Vietnam War Commemoration Seal:

"The United States of America Vietnam War Commemoration" is the official title given to the Department of Defense program in the 2008 National Defense Authorization Act.

A representation of the Vietnam Service Medal (ribbon) rests below the inner rings of the Seal.

The red, white, and blue inner rings represent the flag of the United States of America and recognizes all Americans, both military and civilian, who served or contributed to the Vietnam War effort.

The outer black ring serves as a reminder of those who were killed in action, held as prisoners of war or listed as missing in action during the Vietnam War. The black ring surrounds the red, white and blue rings to call attention to their sacrifices, the sacrifices of their families, and the defense of our nation's freedom.

Within the blue ring are the words "Service, Valor, and Sacrifice"; virtues demonstrated by our veterans during the Vietnam War. The gold-rimmed white star located between the words "Service" and "Valor" represents hope for the families of those veterans for which there has not been a full accounting. The blue-rimmed gold star located between the words "Valor" and "Sacrifice" represents the families of those veterans who paid the ultimate sacrifice during the war. The blue star at the botLaos, Thailand and surrounding waters represent the area of operation where U.S. Armed Forces served. The white number "50th" emblazoned over the map, and the outer and inner gold rings which make traditional use of the color

tom of the inner blue ring represents the families of all veterans and symbolizes their support from home.

At the bottom of the inner blue ring are six white stars, three on each side of the blue star. These six white stars s y m b o l i z e

the contributions and sacrifices made by the United States and its Allies Australia, New Zealand, The Philippines, Republic of Korea, and Thailand.

The center circle contains a map of Vietnam in black outline relief, signifying both the country and the Vietnamese veterans who stood with our veterans. The subdued outlines of Cambodia,



to signify the 50th anniversary, symbolize the specific mission of the Department of Defense program as outlined in the Congressional language "to commemorate the 50th anniversary of the Vietnam War."

The green laurel wreath

signifies honor for all who served.

The seal's blue background is the same color as the canton in the United States Flag.

## Helping Veterans and Family Members to Prevent Medicare Fraud, Waste and Abuse

Senior Medicare Patrols (SMPs) empower and assist Medicare beneficiaries, their families, and caregivers to prevent, detect, and report health care fraud, errors, and abuse through outreach, education, and counseling. SMPs are grant-funded projects of the federal U.S. Administration for Community Living (ACL), U.S. Department of Health and Human Services (HHS). There are 53 SMP Projects in 49 states, the District of Columbia, Guam, Puerto Rico and the Virgin Islands. SMP Hawaii began in 1997 and is sponsored by the Executive Office on Aging, Department of Health, State of Hawaii.

#### PROTECT DETECT REPORT SMPs work in three main areas: 1. Conduct Outreach and Education SMPs give presentations to groups, or

SMPs give presentations to groups, exhibit at events, and work one-on-one with Medicare beneficiaries. In 2013 more than 1 million people were served nationally by the SMP program's outreach and education efforts. The SMP message may be summed up in three

words: protect, detect and report.

To expand outreach, SMP Hawaii partners with county, state and federal organizations, including state and county offices on aging, departments of the Attorney General and Commerce and Consumer Affairs, the Centers for Medicare and Medicaid Services, and the Office of the Inspector General-U.S. Department of Health and Human Services.

#### 2. Engage Volunteers

Protecting an older persons' health, finances, and medical identity while saving precious Medicare dollars is a cause that attracts civic-minded Americans. The SMP program engages over 6,000 volunteers nationally who collectively contribute approximately 150,000 hours each year. SMP Hawaii has over 65 volunteers on the islands of Kauai, Oahu, Maui, Molokai, and Hawaii. In 2014, our volunteers contributed nearly 3,000 hours in training and outreach.

Many SMP Hawaii volunteers are actively involved in their community and volunteer for more than one organization. Antonio "Tony" Garcia is a perfect example. On April 3, 2015, the VA Pacific Islands Healthcare System, Engineering Division, Honolulu, Hawaii, commended Tony for the 14,359 volunteer hours he has provided to veterans during the past 15 years. In 2009, the City and County of Honolulu presented its Bronze Akamai Achievement Award to Tony at the Mayor's 43rd Annual Senior Citizen Recognition Program for his service to seniors as a volunteer with the Hawaii SMP, the State Health Insurance and Assistance Program (SHIP), and the VA.

#### 3. Receive Beneficiary Inquiries

When Medicare beneficiaries, caregivers, and family members contact SMP, the SMP determines whether the inquiry is appropriate for the SMP to resolve or better referred to another organization. If a health care billing error is involved, the SMP provides one-onone counseling to help the beneficiary to correct it. If the SMP's assessment is that fraud or abuse is possible, the SMP makes referrals to the appropriate state and federal agencies to investigate. On occasion, SMP receives inquiries

TRICARE and Medicare. In one case, a veteran had an issue with a very expensive prescription drug that an outof-state pharmacy shipped to him. He returned the drug. When he received his Explanation of Benefits (EOB) and saw how much the pharmacy charged TRICARE, he contacted SMP. SMP helped the veteran contact the pharmacy to secure the pharmacy's assurance that they would refund TRICARE's \$3,000 payment for that single medication.

SMP Hawaii recognizes that the Medicare population now includes younger veterans, who are eligible for Medicare due to disability arising from their military service. SMP would like to expand our educational outreach to our young veterans and all veterans that have Medicare. We welcome working with the VA to carry out this outreach. We also welcome veterans to join our volunteer program.
