#### Daniel K. Akaka Grand Opening and Registration Event

On April 5, 2024, there will be a Grand Opening event from 10 a.m. to 12 p.m. at our new Daniel Kahikina Akaka VA Clinic at 91-1051 Franklin D. Roosevelt Avenue in Kapolei. Please RSVP as soon as possible if you plan to come to this event. We are also excited to invite you to a registration event on the same day. The event is from 1 p.m. to 4 p.m. and will include registration services, whole health, caregiver support, benefits advisors, and much more. If you are curious to see our new clinic before it opens, this is your chance! We expect to see our first patient on April 8, 2024, with a gradual increase in services through the end of the calendar year.

#### **Veteran Art Classes**

VAPIHCS will be hosting painting classes for Veterans from 10 a.m. to 12 p.m. on Wednesdays our new Daniel Kahikina Akaka VA Clinic at 91-1051 Franklin D. Roosevelt Avenue in Kapolei. These classes will be taught by professional artist and Marine Corps Veteran Peter Koutrouba. Painting -and art in general- has wonderful therapeutic qualities, and it can also be a fun way to relax and enjoy yourself. The classes are free, and Veterans who are interested may drop in on Wednesdays. At the end of the year, students will be welcome to submit their work to the national VA art competition.

#### **Neurofeedback Study**

VAPIHCS is hosting a scientific study into a therapy called Neurofeedback at our Honolulu station. This method of therapy has been linked to decreased headaches, improved sleep, improved attention and focus, and improved quality of life. If you are a Veteran who suffered a mild concussion while on active duty and who continues to suffer from headaches, insomnia, and difficulty paying attention, you may be eligible to participate. Contact Dr. Judy Carlson at 808-433-6677 if you would like to participate. You will answer some simple questions, and if you qualify, we will ask you to come see us for 20 free, fun, relaxing sessions of neurofeedback three to five times per week. We will compensate you for your time.

#### **Women Veterans Reproductive Health**

At VAPIHCS, we are committed to providing safe, compassionate, quality care to all our Veterans. <u>Women</u> <u>Veterans</u> are a fast-growing demographic, and VA is committed to women's health. We cover may services specific to our women Veterans, such as well-women's visits, maternity care, and birth control. From sexual health care to menopause care, we are striving to ensure that women Veterans can access everything they need through VA. The Veterans Health Administration is governed at a federal level, which allows us to follow federal guidelines rather than state guidelines when providing women's health care. We can offer counseling about options to women who are pregnant, and in some cases, we may even be able to cover an abortion if it is medically necessary. This is a controversial stance, but national VA leadership feels that women's health is important enough for VA to take this position and support women Veterans in their journey, wherever it may take them.

March is Women's History Month, which makes this a good time to remind women Veterans that VA respects the historic struggles that women have faced to gain equal rights. In health care, and in all things, women deserve equality. If you are a women Veteran who is not yet signed up for VA care, give us a call and let us tell you what we can do for you: 1-800-214-1306.

#### **Guidance on Stakeholder Visits**

VA has issued guidance to facilities across the nation to ensure that stakeholder visits are managed properly. Guidance was issued to ensure standardization across all VA facilities. The plan stresses the importance of collaboration with the community and with elected Representatives, which has always been very important to me. VAPIHCS holds a monthly Congressional Staffer Briefing to ensure full collaboration with those whom our Veterans have elected to represent them in government. We also join the monthly Veteran and Community Task Force chaired by Veteran John Henry Felix. Collaboration is at the heart of all we do here, because serving our communities means participating in them.

Guidance on stakeholder visits seeks to ensure:

- VA staff should ensure that protecting patient privacy is our priority.
- Stakeholder visits should be planned so they do not interfere with normal operations of the facility.
- The Hatch Act must be followed, including all restrictions on political activity or partisan activity as dictated by federal law.
- Extra care must be taken for visits preceding an election.
- Visits should be restricted during disaster situations to ensure that they do not impede disaster relief efforts.
- Media may be invited to stakeholder visits if it does not interfere with normal operations or compromise patient safety or privacy.
- Determinations may be made by the facility Director in regard to other times when stakeholder visits may need to be restricted due to other factors.

Recently I have been honored by visits from Captain Clecky from Navy Medical, Veterans of Foreign Wars (VFW) leadership, Disabled American Veterans (DAV) Leadership, and many more of our partners from both the Defense Health Agency (DHA) and the community. I consider all our work partnering with Veteran Service Organizations (VSOs), other federal agencies, community leaders, and local groups and organizations to be important, and I will always strive for the kind of transparency and accountability that Veterans and taxpayers deserve.

#### **Veteran Transportation Options**

At the VA Pacific Islands Health Care System (VAPIHCS), our coverage area is much different than other VA locations. Veterans cannot simply drive from American Samoa to get to an appointment on Oahu, so our Beneficiary Travel department works hard to help Veterans with the logistics involved in traveling to Oahu for appointments. Once Veterans arrive, they can use our VAPIHCS Courtesy Shuttle to the airport hotel, and then

to their appointments at the Spark Matsunaga Ambulatory Care Center (ACC) or their appointments at Tripler Army Medical Center (TAMC).

On February 1, 2024, the VA Courtesy Shuttle began stopping at Ke'ehi Lagoon as well. This is to allow Oahu Veterans the opportunity to park at Ke'ehi Lagoon, and then ride into the Tripler Army Medical Center (TAMC). Veterans who would like to take the shuttle are encouraged to call with any questions at: (808) 433-7982 anytime between 7:30 a.m. and 4 p.m. Monday through Friday.

The VA Courtesy Shuttle is different from the Veteran Transportation Services (VTS) where a Veteran will call to schedule a pick-up from their home. That is a separate service, which is currently available for Veterans as far out as Mililani going North, Kapolei going west, and into Waikiki, though not past Hawaii Kai. VTS is still available for eligible Veterans, and pickups can be scheduled by calling (808) 433-7982

Both VTS and the VA Courtesy Shuttle are separate from the Handi-Van. The Handi-Van is a public transportation service for persons with disabilities who are unable to ride The Bus. It is fee-based service, unlike VTS and the Courtesy Shuttle which are both free. To learn more about the Handi-Van, Veterans can call: (808) 456-5555.

#### **Parking Structure Closure**

As we seek to make repairs and deliver the best care possible, we will be making repairs to the VA parking structure, building 32, at our Honolulu location. These repairs will require the closure of the entire 4<sup>th</sup> floor of the structure from March 18, 2024, to May 12, 2024. Please plan accordingly.



Kailua-Kona CBOC Move

VAPIHCS will receive keys for the new Kona Community Based Outpatient Clinic (CBOC) on February 23, 2024, which is located at 73-5618 Maiau Street, Suite 200, Kailua-Kona, HI 96740, with the opening date planned for spring of 2024. The new clinic is 12,500 square feet and will have parking stalls reserved in the parking structure, as well as additional parking in the lot of the building.

The new Kona CBOC is conveniently located one block from Costco, and will have appointments for Internal medicine, women's health, mental health, gastroenterology, endocrinology, nephrology, neurology, and podiatry. The clinic will also feature an audiology booth, an on-site lab, and a clinical pharmacist who can assist Veterans with education on disease management. Vaccines will also be available on site. The move to a larger space will allow VAPIHCS to continue to provide care for the Veterans on the west side of Hawaii's Big Island.



### COL. RONALD P. HAN JR. 1961 - 2023



Ron Han is the son of a retired Senior Non-Commissioned Officer who served his country in both the United States Navy and the United States Air Force during the Vietnam conflict. Ron received his commission as a second lieutenant through the Air Force Reserve Officers Training Program at the University of Hawaii earning a Bachelor of Science Degree. He completed over 28 years of activeduty service with the Air Force and Hawaii Air National Guard and is a graduate of Squadron Officer School, Air Command and Staff College, Air War College and was selected and completed the Advanced Officers Logistics Course. Ron also deployed with the tanker task force in support of Operation Allied Force in Europe. He commanded two squadrons, a group, and has held major command staff level positions. He advanced to the rank of Colonel on 17 March 2005 and retired on 1 July 2011. He's served as Director, State Office of Veterans Services since 7 November 2011, under the administrations of Governor Neil Abercrombie, Governor David Ige and Governor Josh Green.







### COL. RONALD P. HAN JR. 1961-2023

Colonel Ronald P. Han Jr. retired from the United States Air Force on 1 July 2011. In his last duty assignment, he served as the commander of the 154th Maintenance Group in the 154th Wing located at Joint Base Pearl Harbor Hickam, Hawaii. He was responsible for over 850 maintainers under one classic and two active associate constructs. His Group partnered with active-duty maintainers in the 15th Maintenance Group in managing all aircraft maintenance support valued at over \$2.6 billion for the following weapon systems: F-22 Raptors, C-17 Globe Master III Airlifters, and KC-135 Stratotankers. One of the largest and most diverse Groups in the entire Air National Guard, his maintainers supported both combat and mobility air force missions, enroute tanker maintenance, and alert air sovereignty taskings.

Colonel Han graduated from Iolani School in Honolulu, Hawaii and earned a Bachelor of Science Degree from the University of Hawaii.

He received his commission as a second lieutenant through the AF Reserve Officers Training Program at the University of Hawaii and served on active duty for over eight years, entering the Air National Guard in 1992. Col Han has attended Squadron Officer School in-residence and completed Air Command and Staff College and Air War College. He has also attended the Advanced Officers Logistics Course and has deployed with the tanker task force in support of Operation Allied Force. Col Han has commanded two squadrons, a group, and has held major command level positions. He advanced to the rank of colonel on 17 March 2005.

Col Han's career spans more than 28 years and is characterized by his awards and decorations that include the Legion of Merit with oak leaf cluster, the Meritorious Service Medal with two oak leaf clusters, the Air Force Commendation Medal with three oak leaf clusters, the Air Force Achievement Medal with oak leaf cluster, the Air Force Outstanding Unit Award with silver oak leaf cluster, the Air Force Organizational Excellence Award with oak leaf cluster, National Defense Service Medal with Bronze Star, Korean Defense Service Medal, Global War on Terrorism Medal, Armed Forces Reserve Medal with Hour Glass, the Hawaii National Guard Medal of Merit, and the Hawaii National Guard Commendation Medal.

He also earned distinction as the 5th Air Forces and Pacific Air Forces Supply Junior Manager of the Year in 1986, selected as the 1989 Air Force Hawaii Military Officer of the Year, and was the 1993 Hawaii National Guard Association Officer of the Year.



Pu'uhonua o Nēnē is a temporary shelter for adults who were houseless prior to the Maui wildfires. The site, managed by Project Vision Hawaii opened on September 29, 2023. It consists of multiple military-grade tents that can house a total of approximately 150 people. Each tent is fully insulated and equipped with cots and other supplies. There are on-site medical facilities, showers, restrooms, and meals. They are offered case management and resource linkage as well as workforce development (stipend payment program) options that can lead to employment.

As of April 24, 2024, 8 veterans are housed.

# **Child Care Subsidies**

The <u>Child Care Connection Hawaii</u> (CCCH) subsidy program use a sliding fee scale for families meeting the income eligibility requirements.

The subsidy amount varies based on the family's gross monthly income, family size, type and cost of care, and, for CCCH only, the hours of the caretaker's work activity.

The subsidy may not cover the full cost of care. Thus, families may be required to pay for some of the child care costs.

For families with children under the age of 13 years, the CCCH program provides subsidies to help pay for a variety of legal child care settings including: care provided in the child's home, care by relatives or friends in their home, before and after school programs, and preschools. The parent/guardian chooses the child care provider most appropriate for their child. Guidance and materials are provided during the office visit to help make this important choice.
