MSgt. Goo Retires

MSgt. Benjamin "Benny" M. K. Goo, Chief of the Aircrew Training Division, is retiring after 33 years of military service. Goo began his military career in 1944 when he was drafted into the Army and sent to training at Camp Hood, Texas. He trained for 17 weeks as an infantry soldier and then went to Europe to the 3rd Army commanded by General George S. Patton.

After fighting as far as Prague, Czechoslovakia, Goo was assigned as the First Sergeant for the 2913th Disciplinary Training Center in Westburg, Germany. The Disciplinary Training Center was a jail for general court martial prisoners and war criminals. MSgt. Goo says he recalls his roommate at the time was the man in charge of hanging the more unfortunate residents of the Center.

Groundbreaking

The new Hawaii Regional Operation Control Center(HIROCC) building will become home for the HANG's 169th AC&WS now housed in an old Wheeler building. The modernization will result in some HANG members of the 150th AC&WS at Kokee, Kauai moving to Oahu to fill increased personnel needs at the 169th.

The full-time air defense mission of manning radar scopes and jet fighters on an around-the-clock basis has been the HANG's responsibility for the past 25 years. The HANG is the only Air National Guard unit in the country with such an active mission.



We seem to be practicing for the "for real" thing forever for practically every wartime probability. It may appear that we have covered all probabilities until we really look at those events which we simulate. Of particular concern are those events listed under contengencies such as fires, bomb damage and expected casualties while we are simultaneously launching and receiving aircraft. How will we respond and manage these crisis events? We did very well when we had to respond to an actual aircraft fire on the flightline: aircrew response, crew chief actions, on-scene command initiatives included moving vulnerable aircraft out of the fire zone. Follow-up management actions included a comprehensive investigation and appropriate corrective actions implemented to avert a similar occurrence.

Responding to a major accident requires the involvement of all our personnel. During our air defense exercises, the command post responds and reacts to information provided by our personnel (usually located out of the shelter area). Inspectors usually "give" situation data to our personnel, waiting to see how our personnel would react to given data. The message may state that "you have noted an aircraft fire in slot 3." It is important that this "simulated message" receives prompt supervisory response and concomitant actions such as notifying the fire department while clearing the ramp area around slot 3 to minimize injury and damage. You may be given a message informing you of injured personnel (We have had similar messages during exercises but our responses were too late because the communication of these messages up channel to the command post was obstructed due to complacency,

mis-direction and/or confusion over desired response. When we have our ORI we can expect to be tested on our response to simulated major accidents. It is critically important that we respond prudently to exercise messages. This is how we practice for the real thing:

Be alert, aware and responsive.

Just in case it slipped your mind, headgear is still required in all outside areas except the flightline. Headgear is not required while working on aircraft or in the vicinity of aircraft whose engines are running. Headgear is also not required in the area of the AGE wash rack. But otherwise headgear is required outside. Your supervisor should be familiar with the type of head gear (cap, utility or baseball) you are authorized to wear.

Are you thinking about leaving the Guard?

So you're thinking of leaving the Guard. You've had enough and you don't need anymore. You can get a part-time job making as much or more anyway.

Well, when you look for that parttime job, make it clear to any potential employer that you will accept employment only under the following conditions:

- 1 You will work only one weekend a month and this will assure you at least three weekends a month for personal pleasure.
- 2 For these two days each month, you want four days' pay plus benefits. Benefits that your spouse may take part in without your presence.
- 3 In addition, he must provide a two-week training session each summer, thus giving you a break from your fulltime job and normal routine.
- 4 During this two weeks, he must furnish pay, meals, housing, medical coverage and insurance. Also, insist on a cut-rate store, recreational equipment, an after-hours clubhouse and a chapel.
- 5 You must have at least \$300 worth of work clothes provided and free meals on work days.
- 6 You expect regular promotion opportunities and longevity raises every few years.
- 7 He should offer \$35,000 of life insurance at an annual cost of \$48.72, with full coverage even when you are not on the part-time job.
- 8 An absolute must is a retirement plan that will entitle you to benefits after only 20 years part-time service and that can be increased by additional service.

- 9 You may relocate anywhere in the United States, at your request and with his assitance, with no loss of pay or benefits.
- 10 The firm must have a travel plan that will enable you to take trips to many parts of the world at reduced rates. Interisland travel must be free.
- 11 Since you are relatively inexperienced and will need progressive training, the firm must provide you an opportunity to attend top rate technical schools and to take unlimited correspondence courses. All this without any loss of pay or at any cost to you. The company must also pay for your tuition should you elect to continue your education at the University of HI or Community Colleges.
- 12 You must be allowed to use company facilities whenever you desire and belong to employee social clubs.



After all, your last part-time employer, the Hawaii Air National Guard, granted you all of this and is working to get even more benefits for the friends you're thinking about leaving behind. After his discharge in November 1946, he returned to his previously held civil service position with the Provost Marshall at Hickam. He joined the Army Reserve and was assigned as the First Sergeant of the 442nd Regiment. His job led to his becoming Chief of Investigation at Hickam.

Goo recalls that earlier in the war, on December 7, 1941 he was recalled to Hickam after the first attack wave. He assisted in removing wounded from the dormitory that today is the headquarters building for the Pacific Air Forces.

In July 1948, he married Miss Jean Parker. This marriage fostered six children, four boys and two girls. His last child, a son, currently attends Arizona State University where he spends most of his time in the wrestling program.

From Hawaii, MSgt. Goo went to Guam in 1949 and worked as a Personnel Administrator at Anderson AFB. In 1951 he moved to California to study electronics under the G. I. Bill. He and his family returned to Hawaii in 1954 where he worked as a service representative for Admiral Radio and Television.

In 1957, Goo became a technician with the Hawaii Air National Guard. He worked on three simulators - the F-86L, the F-102 and the current F-4C.

Benny says, "If I had to do it again, I would do the same thing." He recommends staying in the Guard at least 20 years because it becomes something.

He says he's looking forward to retirement. He plans to golf and take a trip to Europe to tour the route he took in WW II.



If you are a Communications Security Education Program Monitor it will be your job to insure that DD Form 2056 replaces AF Form 30. If you are anyone else, your job is to insure that no classified information is discussed on unsecured telephones. The COMSEC people are listening but they're not the only ones.




