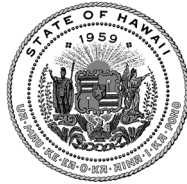

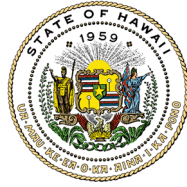

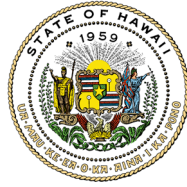
Pursuant to chapter 127A, section 16, Hawaii Revised Statutes, transmitted herewith is the report of purpose of the allotment and expenditures for the Major Disaster Fund (MDF) which was released to the Department of Defense in September, 2018.

The amount of \$5,500,000 was requested. A total of \$5,680,045.57 was expended. \$4,779,697.33 went toward Kilauea Lava disaster efforts, \$677,964.53 went toward emergency response expenditures for Tropical Storm Lane, and \$222,383.71 went toward emergency response expenditures for Tropical Storm Olivia. We are currently working with the Governor's office to address the remaining obligations.
