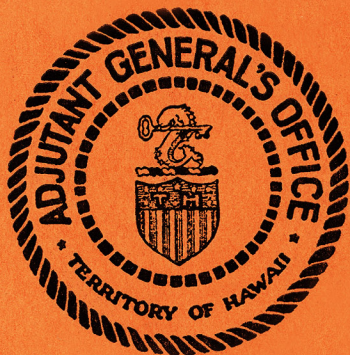

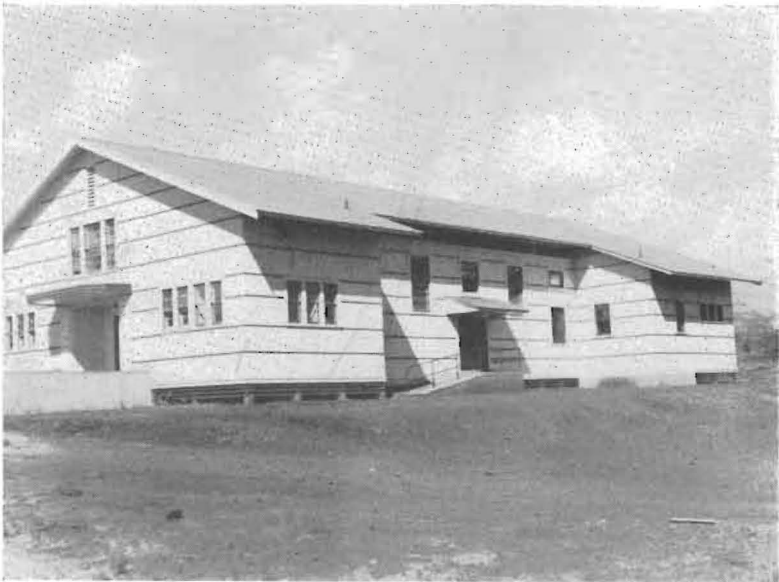

INTRODUCTION

The Military Department, comprising the Headquarters of the Hawaii National Guard, is organized to carry out duties pertaining to administration, training, supply, construction and transportation normally delegated to a command equivalent to a brigade of infantry. The Department is organized into the following Sections:

- I. Administration
- II. Personnel
- III. Operations and Training
- IV. Supply, Finance, Construction and Transportation
- V. Territorial (Staff) Group, (Administrative, Inspection, Ordnance, Medical and Legal)
- VI. Miscellaneous

SECTION I

Administration

There is still great need of additional permanent clerical assistance, as it often happens that in the absence of a section head or other key employees, there is no one available to assume his duties. The office of the Finance and Property Officer is sadly in need of a draftsman to handle the construction work of the Hawaii National Guard, which is growing steadily. It is possible that a saving could be effected the Territory if this could be accomplished.

Office Administration

There has been a marked increase in the volume of correspondence handled in this Department, over 10,000 communications being handled during the past fiscal year. There is still need of added clerical help in this Department. Both the Personnel and Operations and Training Officers are handling their own typing, filing, and detail work which could be handled more efficiently by a clerk-stenographer.

SECTION III

Operations and Training

Captain James T. M. Chang, 298th Infantry, Chief of Section

Armory Training: During the past fiscal year the training of the Hawaii National Guard showed a marked improvement over the previous years. Much attention has been devoted toward training to produce more leaders from among the enlisted men. Officers and men in all units have demonstrated a keen interest in their training.

Marksmanship: Much interest has been evidenced in the competition in small bore marksmanship during the past fiscal year. How-

ever, there is still much work to be done to keep this interest stimulated among the various units to continue to participate in these small bore competitions.

In the Chief of the National Guard Bureau's Regimental Team Match of 1939, Honolulu, the 298th Infantry placed 26th, and the 299th Infantry placed 35th among 40 entries of National Guard Units scattered over the United States. Of the 111 entries in the Chief of the National Guard Bureau's Individual Military Rifle Championship of 1939, the following men in the Hawaii National Guard took places as listed:

The William Randolph Hearst Musketry Competition of 1939 was conducted in February, 1939. The teams were selected by competition within the regiments, the winners being chosen, to compete with other National Guard units on the mainland. The 1938 Hawaii National Guard Rifle Team made a very creditable showing in the National Team Match, placing in the "B" Class and finished in 19th place among 120 teams participating. Sergeant Albert K. T. Ho, Company C, 298th Infantry, won the President's Trophy (High Guardsman). Many awards and trophies were brought back to Hawaii by this team and an excellent display was exhibited in the windows of the Kodak Hawaii, Limited, on Fort Street, Honolulu. This display caused considerable favorable comment.

Company A, 299th Infantry, was awarded a certificate in the Pershing Trophy Matches for having the highest percentage in rifle marksmanship during the target season of 1938 in the Hawaii National Guard.

Schools: The Hawaii National Guard was allotted two places at the Infantry Officers' School for the past fiscal year. Captain Benjamin F. Modisett, 298th Infantry and George D. Becker, 299th Infantry, were the two officers selected as students to pursue the National Guard and Reserve Officers' Course at the Infantry School, Fort Benning, Georgia. The course lasted three months, February 27, 1939, to May 26, 1939, and both officers completed the course with very creditable grades.

Armory Schools for officers and non-commissioned officers were conducted throughout the year under the supervision of Regular Army officers detailed to duty with the Hawaii National Guard as instructors.

Private Lyle M. Lappin, Headquarters Company, 298th Infantry, successfully passed the West Point entrance examinations held at the West Point Preparatory School, Schofield Barracks, T. H., and will enter the Military Academy as the representative of the Hawaii National Guard.

Test Mobilization: During the past fiscal year this Department conducted test mobilizations. These test mobilizations had a dual purpose, not only testing our mobilization plans, but also testing our plans in the protection of the city of Honolulu against sabotage. The 298th Infantry was given four hours to mobilize its units and to man all important installations in the city. In slightly over two hours the entire regiment was assembled in the Honolulu Armory and within fifteen minutes after the troops left the Armory the important installations and streets of Honolulu were manned and patrolled by the 298th Infantry. The Battalions were equipped with radios and continuous communication was maintained with Headquarters throughout the test mobilization until all troops were recalled to the Armory. The Territorial Staff and Detachment were also mobilized to conduct the inspection of the test. The attendance of this mobilization test was excellent. 298th Infantry, officers—97.2% ; E.M. 68.20% . General average 82.91% . Territorial Detachment 81.81% and Territorial Staff 85.71% . General average Territorial Staff and Detachment 83.76% . It is planned to call separate test mobilizations of the 299th Infantry on each Island sometime prior to their 1940 fiscal year annual field training, which will take place during the months of September and October, 1939, on the Islands of Kauai and Maui, respectively.

Field Training: Field Training was conducted as follows: Territorial (State) Staff and Detachment, at Honolulu. The Staff officers and clerks from the Territorial Detachment performed their duties in the Honolulu Armory while the remainder of the enlisted personnel performed their duties at Fort Armstrong, from July 16th to 30th, 1938, inclusive. Seven officers and nineteen enlisted men attended this field training. Major Francis Xavier, Territorial Staff, did not attend this field training, but instead he attended the Regional Selective Service Conference in San Francisco, California, from May 1, to 14, 1939, inclusive. The expenses for this detached duty, including travel, pay and allowances, were paid from Federal funds.

The 298th Infantry held their field training at Schofield Barracks, Oahu, from June 18, to July 2, 1939, inclusive. 46 officers, 1 warrant officer and 644 enlisted men from the active list; 1 inactive officer and 1 299th Infantry officer attached.

The 299th Infantry, 2nd Battalion, with attached units, held their field training at Waimea, Hawaii, from September 10, to 24, 1938, inclusive. 25 officers and 303 enlisted men attended this camp, this being the first time that a large number of trained soldiers ever camped and trained at Waimea, Hawaii.

The First Battalion, Headquarters and Service Companies and Company K held their training at Schofield Barracks, Oahu, from October 15, to 29, 1938, inclusive, with 23 officers, 1 warrant officer and 445 enlisted men. 2 Regular Army Reserve Officers and 2 National Guard Inactive officers were attached for training. This field training period gave Company K their first field training with other units of the 299th.

Organization of new units: On March 19, 1939, the following units were organized on the Island of Kauai: Headquarters and Headquarters Company, 3rd Battalion, 299th Infantry, and Company M, 299th Infantry at Lihue, and Company I, 299th Infantry at Hanapepe. These units were mustered into the service by Captain James T. M. Chang, 298th Infantry, who represented this headquarters. Major Hugh D. Adair, Infantry, DOL, Regular Army Instructor, inspected the units for the Hawaiian Department Commander. After the officers and men of these new units took their oath of office and enlistment the units were turned over to Colonel Gordon C. Ross, the 299th Infantry Regimental Commander.

SECTION IV

Supply, Finance, Transportation and Construction Section Captain Joseph I. deVille, Finance Department, Chief of Section

I—GENERAL

The condition of property and property accounts has shown an improvement during the past year. The work of this section has increased considerably, and recorded transactions show that the past year has been the most active year in the history of the Hawaii National Guard. Over 1100 property vouchers and nearly 500 money vouchers were handled, an all-time record for this office. The addition of new units of the 3rd Battalion, 299th Infantry on the Island of Kauai necessitates an increased volume of work in all Departments. This work has been accomplished without an increase in personnel. The National Guard Bureau has provided this office with an additional clerk, to be paid from Federal funds, effective after July 1, 1939. The increasing volume of work in this section may be readily seen from the following comparative tables covering the past ten years:

A total of 349 requisitions were received and acted on during the past fiscal year, an increase of over 200%. Requisitions are required only for expendable items, non-expendable items being furnished automatically without requisition.

A study of finances reveals that the Territory is losing nearly \$50,000 annually through failure of men to attend Armory Drills and Field Training, and the failure of some units to maintain authorized strength. While perfect attendance is most difficult, it is believed that the large numbers of enlisted men absenting themselves from drills, and to a lesser extent field training, could be reduced. Each private attending all drills and field training has a potential Federal income of \$63.00 per year.

The planned reorganization of the Infantry into what is known as the "Stream-lined" regiment will commence on or about September 1, 1939, and will again necessitate a complete changeover in equipment for all Infantry units. The Salvage and Repair Section was discontinued during the year because of lack of personnel to operate it. This section has been a source of considerable saving in repair funds, both Federal and Territorial, and should be operated when funds again become available.

This section needs a draftsman, if construction is to continue as a function of this section, and a clerk to handle purchases and territorial fiscal records.

II—FISCAL ACCOUNTS

The past year set a new mark for both Territorial and Federal expenditures. The Federal expenditures amounted to \$290,175.54 and Territorial expenditures to \$189,936.83, a ratio of a little more than 3 to 2.

III—PROPERTY

Lack of major items of property has been partially overcome during the present year. The new pattern oil-treated raincoats issued the Guard recently were found unsuitable for this climate and are being completely replaced. Shortages in tentage and typewriters are being corrected as rapidly as funds permit. Shortage of motor transportation is being corrected by the National Guard Bureau to some extent.

IV—TRANSPORTATION

On a number of occasions the U. S. Coast Guard has assisted in transporting personnel and freight to and from various Islands, a service of great help to the Hawaii Guard and much saving of transportation funds.

Transportation activities have increased considerably, and 33 Transportation Requests and 117 Bills of Lading were issued the past year.

Three additional trucks, Dodge 1½ Ton Cargo bodies, were received during the past fiscal year. In order to increase the efficiency of transportation service a reorganization has been completed during the past year which provides for an officer on each Island to act as Transportation Officer for that Island and an officer in Territorial Headquarters to coordinate the transportation activities on all Islands. The Transportation Officer handles all transportation matters pertaining to all units on his particular Island, including the transportation of personnel, shipments of freight, bills-of-lading and transportation requests. V—CONSTRUCTION

Funds were provided by the National Guard Bureau for minor construction and repairs to the Hilo (Hawaii), Kuliouou (Oahu), and Paukukalo (Maui) target ranges. Funds were made available for concrete tent and shower platforms at the Paukukalo, Maui, campsite.

The National Guard Bureau authorized a program of construction which started during the past year at the concurrent campsite at Schofield Barracks. It is anticipated that the National Guard Bureau will authorize additional construction at the campsite at Paukukalo, Maui, which is not adequate for the 299th Infantry at present.

The Department of Public Works handled construction of new armories at Kaunakakai, Lihue, and Hanapepe.

SECTION V

Territorial Staff Group: Administrative, Inspection, Ordnance, Medical and Legal

Adjutant General's Section—Major E. M. Bolton, A.G.D.
Chief of Section

Armory Training Year—Administration of the Inactive Officers and enlisted men has been performed by this Section during the past fiscal year.

Annual Field Training—The annual field training was performed at the Honolulu National Guard Armory from July 16th to 30th, 1938, inclusive. This training period was devoted to the preparation of Plans for Rapid Mobilization and Selective Service Regulations for the manpower of the Territory.

Inspector General's Section—Major H. L. Best, Infantry,
Chief of Section

The activities of the Inspector General's Department for the year ending June 30, 1939, are enumerated herewith.

(a) Attended the annual encampments at Schofield Barracks, Oahu; Paukukalo, Maui; Waimea, Hawaii, and that of the State Detachment at Fort Armstrong, Oahu. A report of these field encampments was made at the close of each camp.

(b) Made the semi-annual audits of the various units of the Hawaii National Guard as required by existing regulations.

(c) Investigated and reported on all applicants for commissions and for enrollments in the West Point Preparatory School at Schofield Barracks.

(d) Made a number of special investigations during the year for which detailed reports were rendered.

(e) Checked and supervised training schedules of all units of the Hawaii National Guard during the entire training year and found them satisfactory and complete.

Ordnance Section—Major Francis Xavier, O.D.,
Chief of Section

During the past fiscal year there was less Ordnance material condemned through fair wear and tear than the few years previous. A few fire control instruments and other ordnance materials were sent to the Hawaiian Ordnance Depot for repairs, as evidenced by the annual inspection report of the Department Ordnance Inspectors.

The Guard was fortunate this fiscal year in obtaining a replacement of twenty-four (24) new U.S. Rifles, U.S. cal. 30 M/1 National Match, to replace the ones which have been used for a number of years by members of the Hawaii National Guard Rifle Teams.

Medical Section—Major Frederic L. Morong, M.C.,
Chief of Section

Sanitation—The 298th Infantry was encamped at Schofield Barracks. The water supply was much improved over the last year's encampment. There was a decided improvement over the refrigeration of food stuff. The general health of both commissioned and enlisted personnel was excellent.

The 2nd Battalion, 299th Infantry, held their encampment at Waimea, Hawaii. Sanitation and general health were excellent, considering conditions and lack of proper facilities for a camp. The Regimental Headquarters, Service Company and Headquarters Company, with 1st Battalion and Company K, held their training at Schofield Barracks, and sanitation and general health were excellent. Smallpox and typhoid prophylaxis inoculations have been much improved throughout the Hawaii National Guard.

Judge Advocate General's Section—Captain Earl R. McGhee,
J.A.G.D., Chief of Section

No intensified training of officers in court-martial procedure has been conducted in the past year. It is recommended that a special court be appointed for the 298th Infantry, a special court for each of the battalions of the 299th Infantry, and a general court appointed for the entire National Guard, the personnel of these courts to serve for one year, during which time they would receive instruction from the Judge Advocate and Regular Army instructors.

More time should be devoted to instruction of officers and non-commissioned officers on the subjects of rendering aid to civil authorities and the enforcement of martial law.

It is recommended that the Military Laws of the Territory of Hawaii be re-compiled and published in mimeographed form to be included in the binders with Territorial Military Regulations and that

all Territorial Military Regulations cite Territorial or Federal laws and/or regulations upon which such Territorial regulations are based.

Sections 97 and 98 of the Revised Laws of Hawaii 1935 were amended at the 1939 Session so as to authorize pay for Territorial and County employees while on active duty as members of the National Guard, and to provide for the non-forfeiture of their employment or of vacation or other privileges by reason of such duty.

Effort is being made to have Congress amend the Act of June 3, 1916, c. 134, Sec. 80, 39 Stat. 203 so as to provide that all employees of the Territory and the Counties who are members of the National Guard shall be entitled to leave of absence from their respective duties, without loss of pay, time, or efficiency rating on all days during which they are engaged in training or other duty ordered or authorized by law.

Miscellaneous—Report of Armory Board

During the fiscal year 1938-39, Captain Dean R. DeMerritt relieved Captain James T. M. Chang as Recorder for the Armory Board. The Board has made several inspections of the various Armories and many repairs have been made—the major one being the complete renovation of the Radio Room in the Honolulu Armory. Armory Board funds have been employed to reduce the expenditures of Territorial allotments, and this has proven of great benefit to our Hawaii National Guard. The loss of these Armory Board funds would indeed cripple the upkeep of our Armories.

TARGET RANGES

The following is a list of ranges operated under the control of the Military Department of the Territory of Hawaii:

Punchbowl, Island of Oahu: Rifle, 200 and 300 yards—14 targets. Small bore, .22 cal., 25, 50, and 100 yards—24 targets. Pistol, 20 targets for slow and rapid fire, 15, 25, and 50 yards.

Kuliouou, Island of Oahu: Rifle, 200 yards—14 targets.

Lahaina, Island of Maui: Rifle, 200 yards—3 targets.

Paukukalo, Island of Maui: Rifle, 1 pit, 6 targets, firing echeloned, 200 and 300 yards. Machine gun 1000-in. small bore and pistol—14 targets.

Waiakea, Island of Hawaii: Rifle, 200, 300, 600, and 1000 yards—6 targets. Pistol and machine gun 1000-in. course—4 targets.

CONCLUSION

The past year has been one of increased growth and expansion of the Hawaii National Guard. Three new Armories, one at Lihue, Kauai, one at Hanapepe, Kauai, and one at Kaunakakai, Molokai, were constructed. The added increments of the 299th Infantry have been as follows:

Battalion Headquarters, Battalion Headquarters Company, and Company M at Lihue, Kauai, and Company I at Hanapepe, Kauai. By this increase we now have the 299th Infantry only lacking Company L to make a complete regiment while the 298th Infantry is still lacking their 3rd Battalion. It has been hoped that the Commanding General, Hawaiian Department, and the War Department would see fit to grant Hawaii these needed increments, but up to the present no success has been attained.

It is deeply appreciated by the Military Department to have had such loyal support from the last Legislature by their splendid co-operation, and Your Excellency's support, for by this concerted assistance, needed repairs have been effected. Iolani Barracks and the Hilo Armory roof are in the process of being renovated and repaired.

It would be of much help to the Hawaii National Guard as a military organization, to the members thereof, and the community as a whole, could we secure a better drill attendance, particularly in the City of Honolulu. The average armory drill attendance percentages for the fiscal year is shown on page 12 of this report. The average attendance for the entire force for the year was 79.92%.

If we could have had an attendance of an additional 20%, it would have meant approximately \$30,750.00 additional drill pay to help the finances of our various Guard located communities and, most vital of all, much valuable additional military training would have been absorbed by the absentees. This deficiency in attendance is primarily due to lack of additional cooperation and planning by the employers of our Guardsmen, while a small portion of the absences are unavoidable.

It is hoped to have better planning by all concerned to improve materially our attendance record for the coming year.

The Hawaii National Guard is appreciative of the splendid assistance given by the U. S. Coast Guard during the past fiscal year. It has been possible through this help that we have been able to make many and much needed inspection trips to the outside Islands. In the erection and operation of the Hawaii National Guard Inter-Island Radio Net their advice and aid have proven invaluable.

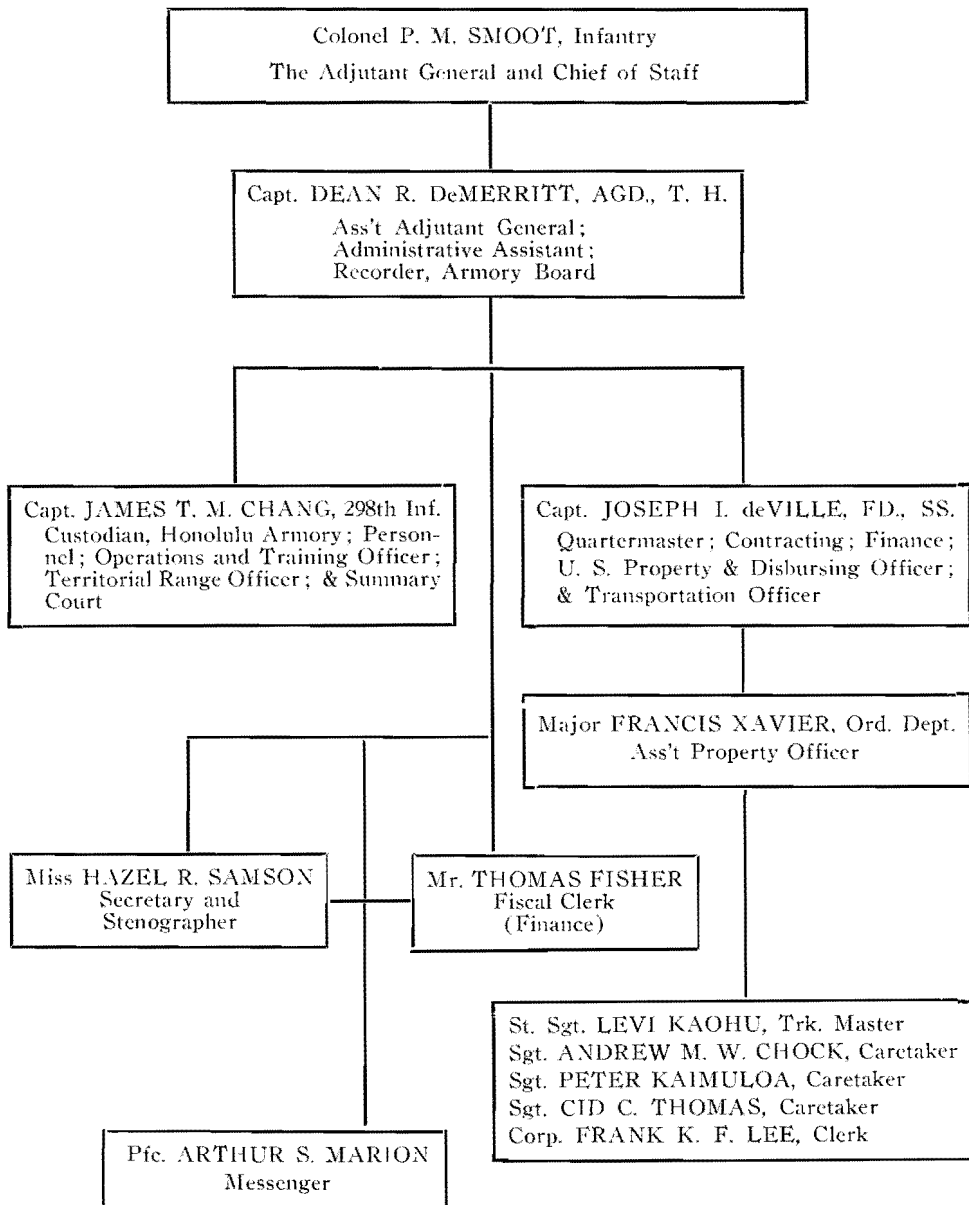
