Hawaii Air National Guard captures majority of National Safety Awards

HONOLULU, Hawaii - Hawaii Air National Guard (HANG) units captured nine out of 16 National Safety Council Awards for 1983 presented to Air National Guard units nationwide. HANG Commander, Brig. Gen. Edward V. Richardson, received the awards on behalf of his units at the National Guard Association of the United States conference held early October in New York city. The awards acknowledged the HANG's outstanding safety record throughout 1983.

The HANG's 154th Composite Group, Hickam Air Force Base, earned the Council's second highest honor, the Award of Merit. The award continued national recognition of the 154th's enviable safety record. In 1980, the group received the National Safety Council's highest decoration, the Award of Honor. The group received Commendation Awards for safety in 1981 and 1982. The 154th is commanded by Col. John S.W. Lee. In addition to the awards to the 154th, one of its subordinate units, the 169th Aircraft Control and Warning Squadron, based at Wheeler Air Force Base, earned a Commendation Award for its 1983 safety record.

Also capturing National Safety Council Awards this year were the Hawaii Air National Guard's 201st Combat Communications Group and several of the group's subordinate units on Oahu and on the neighbor islands. The 201st headquarters unit and the 202nd Combat Communications Flight, both based at Hickam Air Force Base, received Commendation Awards. The 201st Combat Communications Squadron in Hilo and the 201st Combat Communications Flight in Kahului, Maui, also received Commendation Awards. Additionally, the 201st Air Traffic Control Flight, Barbers Point Naval Air Station, and the 202nd Air Traffic Control Flight, Barking Sands, Kauai, received Presidential Award Letters from the National Safety Council. This year's recognition of the safety efforts of the units of the 201st comes on top of 15 previous awards for safety received since 1980. The 201st is commanded by Lt. Col. Ernest T. Shima.

The HANG's smallest unit, the 199th Weather Flight, Wheeler Air Force Base, also received a Presidential Award Letter.

Richardson said of his units receiving more than half of all of the Air National Guard safety awards, "The recognition of the efforts of the men and women of the Hawaii Air National Guard is well deserved. Our organization works hard to protect the lives of our people and the equipment that we are entrusted with to insure that we are always ready to carry out our mission of protecting our country and our state." Richardson also said, "I am very proud to have the efforts of the members of the Hawaii Air National Guard across the state recognized for their efforts nationally. They certainly deserve a lot of credit."

The Hawaii Air National Guard has more than 2,160 members on all of the major islands of Hawaii.

Purple Heart status raised

WASHINGTON—The President has signed legislation to raise the "rank" of the Purple Heart to a place just below the lowest decoration for valor.

Besides adding prestige to the decoration itself, the move is expected to give NCOs who have earned the Purple Heart a few more points toward promotion.

The legislation was contained in the 1985 Defense Authorization Act. An official said that it probably would be a few weeks before the Defense Department issues instructions to the services on how to change their regula-

Originally offered by Sen. John Warner (R-Va.), the legislation calls for the Purple Heart to be given precedence when worn on the uniform by placing it immediately after the lowest decoration for valor.

If a Purple Heart recipient has no valor awards, the Purple Heart would receive the highest precedence when worn on the uniform.

The Bronze Star can be awarded either for valor or for other reasons so, depending on circumstances, the Purple Heart now will rank either above or below it.

One result is expected to be a change in the value of the medal under the Weighted Airman Promotion Systems (WAPS). WAPS now allows only one point for the Purple Heart out of a total possible for medals of 25. The Bronze Star counts five points as do the awards immediately above and below it.

Get in shape!

The National Guard Bureau is moving toward a mandatory physical fitness program for all Air National Members. Commanders will be provided with implementation instructions for the program during the mid-November Senior Commanders Conference.

To ensure that Air National Guard personnel meet the highest possible state of mobilization readiness, the Air Guard will be expanding their present Weight Management Program to include physical fitness.

The program will include an annual 1.5 mile walk/run or three mile walk, where Air Guard members may elect either method. Members who select the 1.5 mile test may run, jog, walk or use a combination of the three as long as they complete the test. The three-mile walk is limited to walking only. Members who jog or run during this test are disqualified and retested.

The performance standards for either method are reflected in minutes:

Walk/Run 1.5 mile

Prior to the physical fitness evaluation, high-risk personnel will be referred to medical personnel. If medical personnel determine that the fitness evaluation methods should not be used, they may recommend evaluation by alternative methods (i.e. treadmill, stationary bicycle) or may provide temporary medical waiver.

Brig. Gen. Edward V. Richardson, Commander, HANG, suggested that commanders encourage all of their members to start their fitness program on a voluntary basis. He stated "I strongly support this policy because you cannot become physically fit overnight and besides, fitness is good for the individual as well as the HANG."

AF officials said it was too soon to say whether the Purple Heart also will count for five points or for some other value.

Whatever the point value, however, the Purple-Heart is expected to move up several notches in the order of decorations and awards worn on the uniform.

"I'm very pleased this has happened," Frank Athanason said in a telephone interview. Athanason, adjutant general of the Military Order of the Purple Heart, said the change was "long overdue to show recognition."

Military identification and information on National Guard status will be requested.

This new card will allow spouses to be identified independently as an eligible user of all Hale Koa Hotel restaurants, lounges, banquet facilities and showrooms.

Orders from overseas-assigned customers must be postmarked via a valid APO/FPO facility. Personnel on temporary duty (TDY) may order from the exchange catalog two weeks before departure and two weeks after return by attaching a copy of their travel orders to the

catalog order form.

To enable TS85 participants and family members the chance to review the catalog prior to deployment, HQ Korea area exchange (KOAX) will arrange direct delivery of 1985 exchange catalogs to TS85 participants through their unit mailing address. More than \$14,000 raised

Janeen receives check from Hawaii National Guard

By Capt. William Bowles HONOLULU, Hawaii—Janeen Fukuhara, a three-year-old Kaneohe girl who underwent a 141/2 hour liver transplant operation in February, was presented a check for more than \$14,000 on November 3, 1984 by the Hawaii National Guard.

The check, presented by the Hawaii National Guard Association and Hawaii National Guard Enlisted Association, resulted from monies raised by the associations through donations and a variety of fund raising events that included barbeque chicken, t-shirt, sushi, and saimin sales.

Presenting the check to Janeen were representatives from the associations, including Maj. Bruce Minato, HNGA President; Col. Haruo Shigezawa, past HNGA President; Master Sgt. Douglas Abe, HNGEA President; and Lt. Col. George Sheridan, Jr., Kokua Janeen Project Chairman. Also assisting with the association's fundraising efforts was the Department of Defense Wives' Club, Na Kuhina Nui O Na Koa

Janeen's grandfather, Sgt. Maj. Ronald Fukuhara, is a guardsman assigned to the Headquarters, State Area Command, Hawaii Army National Guard. He retired in 1982 as a full-time Guard technician but continues to serve as a drill status soldier attending weekend drills.

The association's presentation had been scheduled at the request of the Fukuhara family to be sure Janeen was healthy enough to accept the gift in person. Janeen is still receiving medication to subdue her immune system and prevent the rejection of her transplanted liver. She also has weekly medical checkups and blood tests to monitor her

Since her return to Hawaii in July, Janeen has made steady progress towards recovery. According to her family, she has grown nearly three inches, gained about six pounds. and is able to stand by supporting herself.

FORT LEWIS, Washington—It was cold and nothing like the tropical climate Hawaii Army National Guard soldiers were accustomed to, but they liked it.

The training was rough and demanding, but it was something that the more than 500 soldiers from the 2nd Battalion, 299th Infantry, were used to.

Spec. 4 Benjamin Akana, of Company B normally stationed at Kealakekua on the Big Island, summed up annual training 1984 at Fort Lewis, Washington, this way: "It was right on!"

"It was a different atmosphere and terrain. We had to orient ourselves differently from Hawaii where we got the hills and puus (volcanic cones). Because the terrain was flat, we had to use trees and roads."

"At Fort Lewis you had to use your navigation skills. And that cold weather—30 degrees at times—was something else."

Maj. Paul Leahy, of the WESTCOM United States Army Readiness Group, said

while observing the training: "It was worthwhile to the National Guard soldiers because the facilities at Fort Lewis are not available in Hawaii, such as the training simulation centers and the vast training areas."

An example of Leahy's statement is the Military Operations in Urban Terrain (MOUT) training complex. In Regenburg, a mock Bavarian village in the MOUT, guardsmen in squad and platoon-sized units assaulted occupied buildings through windows and over walls under the scrutiny of active component instructors and evaluators from the active Army's 25th Infantry Division.

The tirehouse in the MOUT complex is a structure with walls made of tires. Hawaii Army National Guard soldiers locked and loaded live ammo into their M16 rifles and under strict supervision, a pair of men would move into the structure and spray the walls with hot lead, simulating an assault into a hostile, occupied structure.

At Fort Lewis, the men of the 2nd Bat-

talion also did not use conventional stand inline rifle ranges. After the firing line was cleared by an M60 machine gun, soldiers with live ammunition in their weapons moved up, closely supervised by range control officers.

A noncommissioned officer watching from a tower, controlled pop-up targets that presented themselves to the advancing soldiers, halting them unless they were shot down. Second Lt. Thomas A. Adarme, Company A platoon leader said, "This is not like live firing back home. The men really enjoy this exercise."

Not to be left out, the 81-millimeter mortar platoons also engaged in live fire assisted by members of the 487th fire support team (FIST) of Oahu. Overcoming early difficulties brought about by borrowing mortars from the Washington National Guard, the mortar platoons completed their required live fire. The men chorused the aiming coordinates radioed from the FIST spotters, set charges, and sent round after round towards the various targets, scoring hits.

With conventional means of battle being honed to precision, live fire of another kind went on in blackened, barn-sized buildings. In front of a large simulated battlefield, men on full-sized jeeps aimed ruby-red laser beams onto a screen simulating the fire of a Tubular Launched Optically Tracked Wire Guided Missile (TOW) electronically scrapping tanks and armored vehicles.

After a week of intensive squad, platoon, and company training, the soldiers of the

2nd Battalion took a break during the middle weekend, visiting Vancouver and other Pacific Northwest cities. They returned ready and primed for the battalion-sized field training exercise (FTX) that followed.


On a cold, starry Monday morning, the operation orders were issued. Companies of men and equipment assembled and moved out in staggered tactical convoys meeting at a designated rallying point several kilometers away.

An active component evaluator from the 25th Division observing the battalion's movement from a helicopter noted the professionalism in spacing movement, and the orderly dispersion of each company as they broke off the battalion train to their initial defensive positions. The recon patrols, invisible from the air, had signaled the companies and made their infiltration into their respective areas almost undetectable.

The morning had been in the low 30s. Although the day would warm into the upper 60s, the evening would bring back the near freezing temperatures and fog, which became the main aggressor on the 2nd Battalion, inhibiting movement and navigation.

Maj. Gen. Alexis T. Lum, the Adjutant General of the State of Hawaii, visiting the troops in the field said, "The morale was high among the soldiers in spite of the cold temperatures and inhospitable weather."

To and from the field and various training areas, the men and equipment were transported on vehicles driven by members of the 1154th Transportation Company of Oahu

that were attached to the 2nd Battalion.

In the field, the soldiers were trucked hot breakfast and dinners prepared in the barracks by the company's mess unit. Staff Sgt. Rod Sakamoto, cook at the Headquarters mess facility said, "This is good training for the cooks. For the first time, most of the cooks were using modern garrison-type cooking equipment as opposed to field equipment that is normally used during drill." Sakamoto said that he and two other cooks used this type of equipment before, but this was not the case for the majority of the cooks. "We usually use the field stove and ovens," he said.

Lunch in the field consisted of Meals Ready to Eat (MRE). These are the Army's new plastic foil-pouched meals, different from the old canned rations.

As the scenario for the field exercise unfolded, the battalion split into several units playing defenders and aggressors. Each unit made several moves setting up and

breaking camp each time.

Doc "Gallup-s" to marathon victory

Lt. Col. (Dr.) James D. Gallup, the State Air Surgeon for the Hawaii Air National Guard, joined 10,000 long-distance runners from around the world on November 4, 1984 to compete in the 9th Annual Marine Corps Marathon. The 26.2-mile course, nicknamed "The Marathon of Monuments" wound through the heart of the nation's capital.

Gallup, who joined the Hawaii Air National Guard in 1978, was the only person from Hawaii who qualified to compete in the race. As a member of the All Guard Team, Gallup took top honors in the National Guard members' Master's Division (over 40) with a time of 2:43:32, and placed 135th overall. He completed the race despite recovering from a crushed tibia (bone between the knee and ankle). He had not run more than nine miles at a time in the weeks before the marathon.

While individual National Guard members have been part of the Marine Corps Marathon since its beginning in 1976, last year was the first time an All Guard Team was entered. This year's All Guard Team was selected on Mary 6, 1984 in Lincoln. Nebraska, where more than 600 Army and Air Guard runners from across the nation participated in the annual Lincoln Marathon (a total of seven runners, three from the Air and four from the Army Guard, represented Hawaii). Top National Guard finishers in the Lincoln race were selected to represent the National Guard in the Marine Corps competition. Gallup placed fourth to make the five-man Master's team.

Gallup's background and running accomplishments are impressive. A 1957 graduate of the University of Wyoming in Laramine, Gallup attended the University of Rochester Medical School in Rochester, New York, receiving his medical degree in 1961. He is currently a pathologist with the Honolulu Medical group.

Upon arriving in Hawaii with his family in February 1974, Gallup decided against buying a car for himself. Instead, he rode a bike to work. He found Honolulu traffic dangerous for cycling, and looked for another means of transportation. At that time, Gallup was working in an office with Dr.

Jack Scaff, founder of the Honolulu Marathon Clinic. When Scaff started the clinic in March 1974, Gallup and his family were in attendance. He has been running ever since.

It is more the rule than the exception for Gallup to run 100 miles each week. His 100mile "quota" includes running 13 miles (round trin) daily from his home in Hawaii Kai to his downtown office. "I start at 7 a.m. and get to the office a little before 8 a.m." If that sounds like a long haul, he continues, "I used to work over at Hickam AFB, and once got arrested for running across the taxiway near Lagoon Drive (to save time)." Did the incident stop him from running? "No, but I stopped running across the taxiway!"

Gallup has held American age group records in the 1/2 marathon (1982) and 50-miler (1978). He also won the National Master's AAU Championship in 1976. Nowadays, he runs about 20-40 races in Honolulu each year, and is currently training for the Honolulu Marathon on December 9, 1984.

Gallup and his wife, Maxine, have two sons, Timothy, who is working in California, and Derek, a high school junior and cross country runner for Iolani. We wish the Doc well in all his future "gallup-s!"


