Hawaii salutes survivors 50th anniversary of Pearl Harbor attack

Gov. John Waihee hosted the State of Hawaii Survivors Day Program at the USS Arizona Memorial Visitor Center, Dec. 5. The program was developed by the State Department of Defense to pay

tribute to survivors of the Dec. 7, 1941, attack on Pearl Harbor. The National Park Service and State Department of Agriculture provided outstanding logistical support to the DOD.

Entertainer Al Harrington served as the master of ceremonies for the program, which featured the Hawaii National Guard's 111th Army Band, Kamehameha Schools Children's Choir, Chinky Mahoe's Hula Halau O Ka Wai Liula and Ihilani Miller.

During the portion of the program titled "A Tribute to the Battleships," the governors or representatives from the states with battleships bombed in Pearl Harbor recounted the fateful Sunday morning fifty years earlier. After the nine states were recognized, a survivor and a park ranger placed a wreath at the foot of ceremonial masts constructed by the Hawaii Army National Guard. (The masts were donated to the USS Arizona Memorial Visitor Center a week later.)

While some Guard personnel were highly visible, providing musical accompaniment and escorting VIPs, most of the department's support was behind the scenes. For example, state and Guard engineering employees worked overtime to arrange greenery and set up the masts that were the focal point of the tribute. In addition to performing at the ceremony, the 111th Army Band also took the lead in developing the program. Other staffers took care of the many logistical details such as communication, transportation and audiovisual coverage. In total, more than 350 state DOD personnel assisted with the Survivors Day commemoration.

In conjunction with other December 7th ceremonies, the Hawaii Air National Guard conducted six flybys, Dec. 7-8. The flybys, each involving four F-15 Eagle jets from the 154th Composite Group flying in "a missing man formation," were over the USS Arizona Memorial, Hickam Air Force Base (twice), Bellows Air Force Station, Wheeler Army Airfield and Schofield Barracks.

Kauai: Guard helps during flood

Eleven Air and five Army Guard personnel assisted county and civil defense officials when heavy rains and flooding hit northeast Kauai with little warning, Dec. 14. Guard personnel, equipped with radios and 2 1/2-ton trucks, were stationed at the County's Civil Defense Emergency Operating Center and the Kapaa and Hanapepe Armories.

Commanded by Lt. Col. Myron Dobashi, Air Guard personnel stood

watch until the evening, when they were relieved by Army Guard soldiers. Other Kauai soldiers were activated after the storm to clean up mud and debris at the Kapaa Armory, which was flooded by two feet of water. Three journalists from the Army Guard were sent from Oahu to document the relief effort.

On Sunday, Gov. John Waihee, accompanied by Maj. Gen. Edward V. Richardson, the state adjutant general, flew to Kauai to survey the most heavily

damaged areas. The governor and adjutant general were joined by Kauai Mayor Joanne Yukimura and the Kauai county engineer. The aerial portion of the survey was conducted with an Army Guard UH-1H helicopter; ground survey was from two sedans and two high-mobility multipurpose wheeled vehicles (HMMWVs).

On Monday, the Army Guard's U-21 flew U.S. Congresswoman Patsy (Kauai continued on page 4)

the solar eclipse. The Army and the Air Guard worked jointly with State Civil Defense to assist Maui County firefighters in extinguishing the blaze which razed 12,500 acres on Molokai in late June. On July 11, the Guard supported Big Island and Maui officials in ensuring the safety of residents and visitors viewing the total solar eclipse by providing safety patrols, communication and medical services.

The Guard's most recent emergency response came on December 11 in the wake of tropical cyclone Val in American Samoa. The Air Guard's C-130 transported the governor of American Samoa, damage assessment personnel and emergency supplies to the stricken island and performed a search and rescue mission. Just three days later, our airmen and soldiers on Kauai were on active duty during the aftermath of the flash flood in the Anahola area.

In September, the Hawaii National Guard Association (HNGA) hosted the 113th National Guard Association of the United States annual conference at the Sheraton Waikiki Hotel. Nearly 3,000 members and guests attended the highly successful event that culminated five years of planning, coordination and hard work by HNGA officers, staff, spouses and friends.

Most recently, department personnel worked jointly to put on the State of Hawaii Survivors Day Program at the USS Arizona Memorial Visitor Center as part of the 50th anniversary commemoration activities for Pearl Harbor. More than 350 of our volunteers worked countless hours hosting dignitaries and guests as well as providing logistical support and musical talent for the program. It was an outstanding effort and our people did their usual best. The 111th Army Band and the 199th Tactical Fighter Squadron (TFS) capped off the year with a performance and flyby during the nationally-televised Eagle Aloha Bowl, December 25. A big mahalo to the band and the 199th TFS.

State Civil Defense (SCD) continued to monitor the eight-year eruption of Kilauea Volcano, which destroyed homes and covered Kaimu Bay and Kalapana Black Sand Beach in the Puna district of the Big Island. In March, heavy rains flooded the north windward shores and south central portions of Oahu, forcing the opening of evacuation shelters and disaster application centers. As part of its unending effort to improve Hawaii's emergency and disaster response program, SCD also published updated tidal wave evacuation maps in all county telephone directories and has established an agreement to broadcast emergency information on cable television.

The long-awaited Hawaii State Veterans Cemetery was officially opened July 31, thanks to the hardworking staff of the Office of Veterans Services (OVS). When completed in 1993, the cemetery will provide a final resting place for more than 80,000 Hawaii veterans. I also commend the OVS for increasing the number of veterans and dependents served in 1991 by 11 percent.

Without a doubt, we are at the close of an extremely eventful year and at the crossroads of even greater accomplishments as we face the challenges of 1992.

The Air Guard will be upgrading its F-15 Eagles and will complete the transition early next year. The first two trainers arrived this month and have enhanced weapons and radar capability. The multi-stage improvement program will be a quantum leap for us in terms of combat capabilities.

Activation of the 203rd Air Refueling Squadron is ongoing. In addition to enhancing our support to fighter aircraft, the KC-135R Stratotanker will enable us to transport Guard units to the neighbor islands and the mainland.

Though the threat of drastic personnel cuts under the Army's Program Assumption Memorandum and Quicksilver was abated, we can still expect major changes in the Army Guard's force structure. The following proposals are presently in the talking stages: the conversion of the 1st Battalion, 193rd Aviation, to a medium lift helicopter unit with CH-47 Chinook helicopters; activation of an honor guard detachment; and major equipment changes, including replacement of our eight-passenger U-21 fixed-wing aircraft with a 19-passenger Fairchild C-26 in June 1992.

I have briefly covered some of our future program initiatives because I feel it is important that you know what's going on within your organization. As more information becomes available, I will pass it on to you.

I'd like to close by again thanking each of you for your outstanding performance and support over the last ten months. The numerous accomplishments of the department would not have been possible without your hard work and dedication. Moreover, I am confident that our proven abilities and professionalism will serve us well as we take on the future challenges that await us in the new year. We are truly an organization of excellence with people committed to total quality, pride and ownership in everything we do.

My wife, Celia, joins me in extending our warmest holiday greetings to you and your family along with our best wishes for a joyous Christmas and New Year. Mele Kalikimaka me ka Hauoli Makahiki Hou.

As I look back over my first ten months as the Adjutant General, I feel an immense sense of pride and gratitude for what we have accomplished this year. Time and again, the department's timely response to events of international, national and local significance demonstrated our capability to not only carry out our missions, but to do an outstanding job in all our endeavors. I thank all of you for your support during this extremely busy period that included the following achievements:

Though Hawaii National Guard (HING) units were not deployed for Operations Desert Shield or Desert Storm, the HING took on some of the duties assigned to deployed active duty forces. The Air Guard's C-130 conducted the Air Force's "Coral Run" between Johnston and Midway Islands, and Air Guard security police performed duties at Hickam Air Force Base. The Army Guard also did its share, providing maintenance support for Kaneohe Marine tracked vehicles shipped to and from Saudi Arabia. In August, four Army Guard medics deployed to the Persian Gulf to treat American and allied military personnel.

The February 27 ceasefire brought an early end to the conflict, and the department led a statewide effort to personally greet 8,500 soldiers, sailors, airmen and Marines returning from the Persian Gulf. Our people worked closely with the state Department of Transportation, Department of Education and Chamber of Commerce of Hawaii to collect and distribute the 12,000 leis sewn by school children across the state. HING units participated in welcome home parades and celebrations on Oahu and the neighbor islands.

In addition to annual training, Guard personnel were kept busy this summer with a fire on Molokai and

National Defense Service Medal wear authorized

President George Bush signed an executive order Oct. 1, officially authorizing the wear of the National Defense Service Medal (NDSM) by members of the National Guard and Reserves who were part of the selected reserve in good standing from Aug. 2, 1990, to a date to be determined.

The Hawaii Air National Guard's Consolidated Base Personnel Office is compiling an

updated list and will issue the medal to all authorized enlisted members.

Hawaii Army National Guard (HIARNG) commanders are authorized to distribute the original issue medal. The HIARNG Personnel Office (G-1) is ordering the ribbons for distribution to soldiers. (Permanent orders are not required.)

A service star will be worn by soldiers and airmen who are receiving second or subsequent awards of the NDSM.

Tropical cyclones batter Pacific Isles

From late November to mid-December, several Pacific islands saw three tropical cyclones enter local waters with devastating results.

Guam and Micronesia are still reeling from the impact of Super Typhoon Yuri, which struck the area beginning Nov. 25. Packing 160+ mph winds with gusts to 200 mph, Yuri battered the area for five days before moving on. Federal Emergency Management Agency (FEMA) disaster assistance teams are currently on the two islands, following declarations of major disasters by the President.

Just as Yuri was completing its westward sweep, Typhoon Zelda hit the

Marshall Islands, Nov. 28, with 100+ mph winds. Again, a major disaster was declared and a FEMA team was sent to evaluate damages from Zelda's two-day onslaught.

While disaster assistance teams were settling in on Guam, Micronesia and the Marshalls, Tropical Cyclone Val battered Western and American Samoa for three days, beginning Dec. 9. Packing 100+ mph winds with gusts to 150 mph, Val is charged with 13 deaths and leaving thousands homeless. Local officials say the cyclone destroyed nearly 80 percent of all crops.

International relief efforts were underway almost immediately for Western and American Samoa. A Hawaii Air National Guard (HIANG) C-130 cargo

aircraft was one of the first at the scene, carrying 35 passengers and 6,000 pounds of emergency relief cargo to American Samoa, Dec. 11. Passengers included American Samoa Gov. Peter Coleman and personnel from FEMA, American Red Cross, Coast Guard and Army Corps of Engineers. Relief supplies were gathered through the Office of American Samoan Affairs on Oahu and included water containers, shelter tarpaulins and medical supplies. Ten HIANG aircrew and maintenance personnel were placed on active duty to operate and service the aircraft. Before returning to Honolulu, the C-130 conducted a search and rescue mission.

Val's timing was unusually cruel, as the Samoa Islands are still recovering

from Tropical Cyclone Ofa, which struck the area early last year. According to local reports, storm damages from Val could climb to \$100 million or higher, far greater than that caused by Ofa.

In response to the four Presidential Major Disaster Declarations, FEMA has tapped resources nationwide to assemble the required disaster survey and assistance teams. Pacific region resources have been especially taxed with ongoing recovery efforts in California for the recent Oakland fire, Loma Prieta earthquake and Hurricane Hugo.

Including the Kalapana lava flow and the disaster declaration for American Samoa, the Pacific region has had a total of five major natural disasters since mid-1991.

Flood awareness: before, during and after

Flooding — whether from winter storms, high surf or hurricanes—is Hawaii's leading cause of property damage. Understanding the dangers of flooding and knowing what to do in case of a flood emergency can help to protect you and your family and property from harm. Some important things to know:

Before the flood

Do you live in a flood-prone

area? (If you aren't sure, check the white pages of your telephone directory). Plan ahead and know what to do and where to go during a flash flood emergency. Make sure that storm drains are free of trash and brush.

If a flash flood watch is issued for your area

Listen to the radio/TV advisories and reports from the National Weather Service and

public safety agencies, and *be prepared to leave immediately*. If you're on the road, watch for flooding at road dips, bridges and low areas; also look for signs of heavy rainfall in the distance (i.e. thunder, lightning).

If a flash flood warning is issued

Act quickly because flooding may have already begun. Don't attempt to cross a

flowing stream if the water level is knee-level or higher. If you're driving, don't try to ford dips of unknown depth; if your vehicle stalls, immediately abandon it and seek higher ground. (Rapidly rising water can easily wash away a vehicle and its occupants.) Be extra cautious when driving at night when it's harder to spot flood danger, and tune in to the radio or TV for official weather updates.

After a warning or watch is canceled

Continue to listen to the radio or TV for follow-up information — flooding sometimes resumes.

Mink to Kauai to survey the damage. Maj. Theodore Daligdig, battalion administrative specialist, drove Mink to the most extensively damaged sites, including the Anahola area.

Gov. Waihee has declared the county a major disaster area. The proclamation makes available state disaster funds to repair damage to public property such as roads, sewers and waterlines. The proclamation also makes available individual and business loans, and loans to assist with disaster recovery for qualified individuals or businesses. In addition, the proclamation will provide state income tax relief for qualified taxpayers suffering natural disaster losses.

State and county civil defense officials, in conjunction with Federal Emergency Management Agency, Small Business Administration and Kauai County officials, are presently conducting a more detailed survey to accurately determine total damage estimates. Thus far, civil defense officials estimate damages to public property at more than \$4.6 million and private property damage at \$2.5 million. The greatest damage was to individual residences, personal effects, private automobiles and farms.

Chaplain Kinoshita retires from Army Guard

A reputation of inspiration and caring is what Chaplain (Col.) Carl K. Kinoshita, Hawaii Army National Guard, has built over his 23 years of military service. "I go to his service just because he is Chaplain Kinoshita," stated Lt. Col. Melvin K. Imai, a mobilization planner with G-1 (personnel).

At 59 years of age, the trim and spry Kinoshita thinks nothing of donning a Kevlar helmet, protective mask and camouflage make-up to carry the ministry into the field. "The job of a military chaplain is to spend 50 percent of the time in the field," said Kinoshita. "It's called the ministry of presence."

Living up to his words, the

chaplain then boarded a high-mobility multipurpose wheeled vehicle (HMMWV) driven by his assistant and headed out to visit infantry and support units training at the Pohakuloa Training Area this summer. "The best part of my job is meeting people from all walks of life," he said.

Indeed, Kinoshita's presence is appreciated by the troops he visits. "It makes me feel better knowing the man upstairs is looking out for us," said Spec. Andrew DeLeon, 292nd Supply and Service Company, after attending one of the chaplain's non-denominational services. Chaplain assistant Staff Sgt. Gerardo A. Pascua said Kinoshita "makes his service personable and relates his service to each group."

In addition to spiritual counseling, Kinoshita also finds himself giving out a lot of practical advice and information. He spends much of his time counseling soldiers on personal, family and occupational concerns. Having counseled many soldiers and with his own son in the Guard, Kinoshita knows the strain that families of Guard members experience. "The time away from home and extra duty hours can be difficult on the family. It is one of the most common problems I deal with," he said. The chaplain added, "Counseling is not just a lot of discussion. Often, it's being able to direct the individual to the right resources or to someone who may be more qualified to help."

When asked what the most

gratifying part of his job was, Kinoshita responded, "It's really nice to hear when things have worked out for somebody who needed help."

Kinoshita's retirement plans include recruiting chaplains for the Guard. "The Guard will need a minimum of three new

chaplains after I retire," said Kinoshita, who would like to see all the vacancies filled.

Kinoshita is the pastor of the First Baptist Church of Wahiawa. Before retiring from the Hawaii Army National Guard, Dec. 21, he was presented the Legion of Merit medal. His last annual training was spent with the 1st Battalion, 299th Infantry, the unit he was assigned to before going to Vietnam.

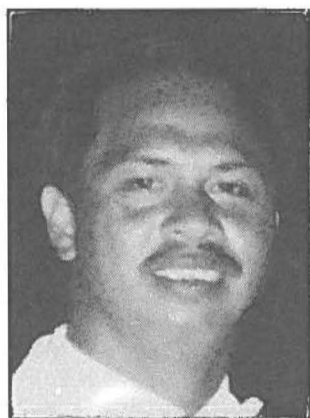
Commissioned chaplains must be ordained and have completed college and 90 hours of graduate study. All clergy must attend a six-week basic chaplain school and most must obtain the endorsement of their religious organization. Kinoshita says chaplain candidates should also be FAT: Faithful, Available and Teachable.

Army sergeants major retire

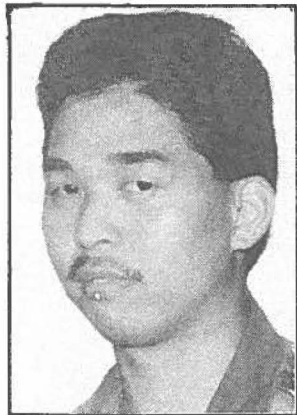

1989. He and his wife, Thelma, live in Ewa Beach and have six children.

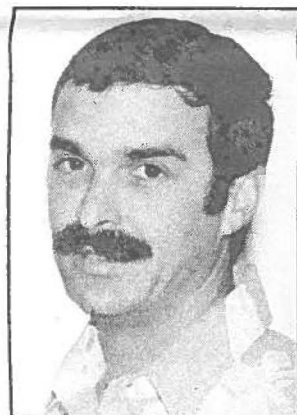

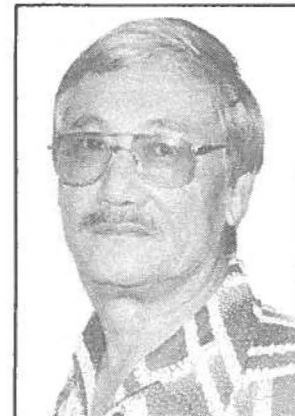

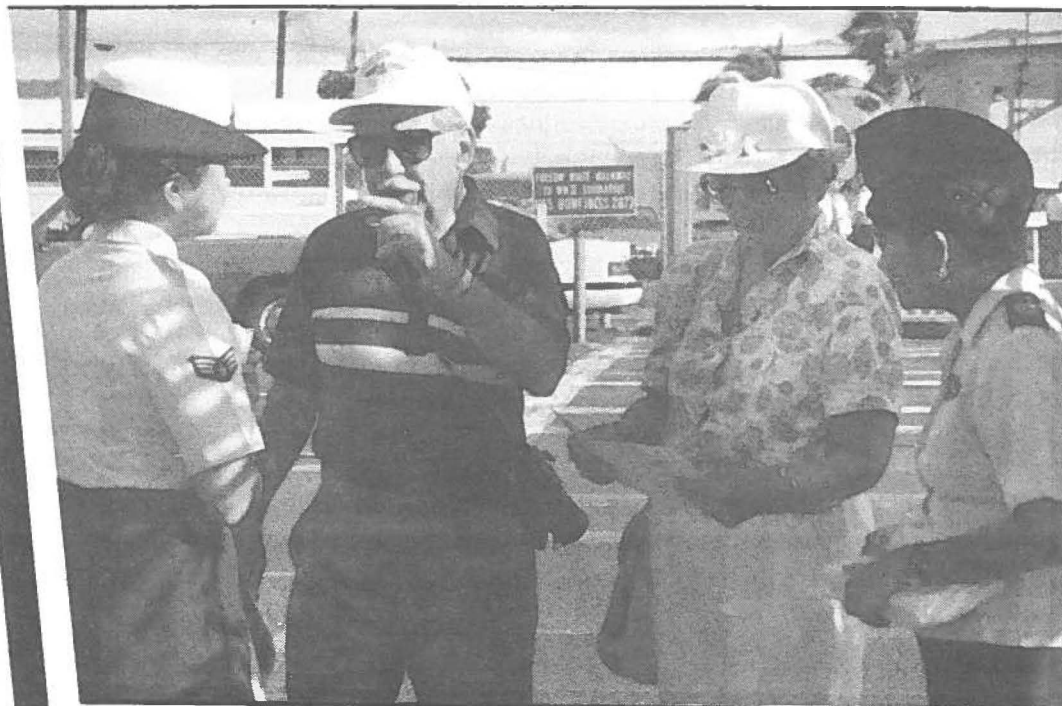

Hawaii Guard activated for WWII

In the late 1930s, as war loomed in Europe and the Pacific, it became clear to previously neutral countries that regional conflicts were escalating into a global contest. Many countries braced for possible entry into another world war, including the United States, which activated reservists to fill a newly expanded active Army. The National Guard of Hawaii was tapped in the second increment of the federal call-up, its 298th and 299th Infantry Regiments to serve with the Army's 24th Infantry Division in the South Pacific.

American patriotism was at an all-time high and there was widespread support for the territory's citizen soldiers, who would later be dubbed "Hawaii's Own." Elaborate farewell ceremonies were held on the neighbor islands and local businesses and residents donated monies to purchase personal items and recreational equipment for the men. On Oct. 15, 1940, more than 1,600 National Guard soldiers from throughout the territory reported to Schofield Barracks, Oahu, for military training and preparation.

The soldiers settled into military life quickly and completely. Within 14 working days, the Third Regiment, Combat Engineers, 298th Infantry, had constructed a wooden cantonment in the area of Schofield known as National Guard Woods. Barracks construction for the 299th followed,

with soldiers moving into their new quarters on Dec. 3. Col. Wilhelm A. Andersen was the commander of the 298th Infantry, stationed at the Honolulu Armory. Col. Gordon C. Ross commanded the 299th Infantry, then stationed at Iolani Barracks.

In early April, the territorial legislature expressed concern about the vulnerability of neighbor islands to enemy attack. Later that month, neighbor island units began returning to their home stations. The units were

involved in numerous military construction projects and played major roles in building facilities at Hilo Airport, Hawaii; Barking Sands, Kauai; and Homestead Field, Molokai.

For many months after the Dec. 7 attack on Pearl Harbor, both regiments were assigned to beach defense duties. On Oahu, Guard soldiers took over for active Army forces deployed from Schofield.

In spring 1942, Guardsmen of Japanese descent were formed

into a separate group that later became the 100th Infantry Battalion. The 299th Infantry was so depleted by this reorganization that the regiment was inactivated and its remaining members transferred to the 298th.

Due to numerous personnel changes and transfers, Hawaii Guard soldiers comprised only 15 percent of the 298th in 1943 when the regiment was sent to Guadalcanal and Espiritu Santo to guard port facilities. (Local and mainland draftees made up

the majority of the unit, in nearly equal numbers.)

Most elements returned to Oahu in late 1944, and all but one of the battalions were deactivated on Oct. 10, 1945. Separation papers sent to the National Guard of Hawaii headquarters showed that local Guardsmen served longer and accrued more service points than any other Hawaii military group.

Guardsman captures first Japanese prisoner of war



Cpl. David M. Akui

In the predawn hours of Dec. 8, 1941, Corporal David M. Akui, 21, of the 298th Infantry, was on active duty patrolling the beach at Bellows Field, Oahu, when he spotted what he thought was a turtle in the offshore darkness. As the object came closer, however, Akui realized it was a man swimming ashore. Akui challenged the Asian man and ordered him to halt. Bayoneted rifle

in one hand, Akui cranked up the field phone with his free hand and called his commander, Lt. P.C. Plybon. Plybon and his party arrived immediately and the exhausted stranger was tied up and driven away.

At daybreak a dark, bulky object was sighted on the reef about 1 1/2 miles offshore. A reconnaissance plane determined the object to be an 80-foot

Japanese midget submarine, one of five two-man subs assigned to attack Pearl Harbor the previous morning. It turned out that Akui had captured Ensign Kazuo Sakamaki, the commander of midget submarine number 19 and the first Japanese prisoner of World War II.

Later investigation revealed that a damaged gyroscope and depth charges from two Ame-

rican destroyers had prevented Sakamaki's sub from entering the harbor. The sub was setting out for a rendezvous point off Lanai when its crew collapsed from fatigue and the sub washed onto the reef near Kaneohe.

Akui declined several opportunities to meet with Sakamaki during and after the war. A dedicated military man, Akui went

on to fight in the Central Pacific campaign and in the India-Burma campaign with Merrill's Marauders. He served almost 20 years in the Guard and rose to the rank of master sergeant. He left the Guard in 1959 to join the Navy Reserve, retiring as a chief utilitiesman in 1975.

Akui passed away in 1987. His wife and four children live in Kaneohe.

Hawaii Guard rifle team wins state championship

The Hawaii National Guard (HING) highpower rifle team beat military and civilian teams to win the 1991 State National Rifle Association Highpower Rifle Team Championship, Oct. 19-20. The highpower rifle team members are Staff Sgt. Hubert M. Chang, Staff Sgt. Norman Y.Y. Tyau, Sgt. Earl S. Iwata and Sgt. Shawn H. Kono.

The HING's expert class team captured the state championship, leading the way for its marksmanship class shooters, who finished third. The expert and marksman teams were coached by Sgt. Iwata and Lt. Col. Vern T. Miyagi, respectively.

Tech Sgt. Galen M. Yamada was the Guard's big winner in individual competition, winning the silver medal in the overall individual state championship. Close behind Yamada were Iwata and Miyagi, who placed fourth and fifth, respectively. Miyagi placed first in the expert class, and Iwata captured the state match for prone, rapid fire at 300 yards.

Sgt. Kono brought home the gold in the Excellence in Competition "Leg" Match, earning 10 points toward the service rifle Distinguished Rifleman Badge.

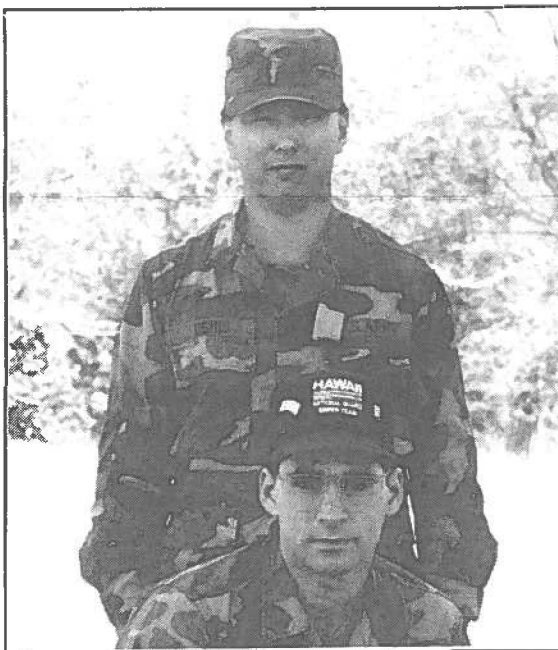

The Alcohol and Drug Abuse Prevention and Control Program (ADAPCP) at Schofield Barracks is fortunate to have Carole Hill as an employee. And so are we. Hill, a former active duty sailor, Marine Corps civilian employee, and now a soldier with the 29th Infantry Brigade (Separate), is the training instructor at ADAPCP.

The Schofield Barracks ADAPCP is a composite service for soldiers. It encompasses drug and alcohol counseling, urinalysis testing, referral, training and educational services. Hill is

responsible for drug and alcohol training and education statewide.

Hill gives time, energy and expertise to her job, but she also gives more. She gives her heart.

Her compassionate concern for soldiers is boldfaced. She wants to help soldiers BEFORE they get into trouble and suffer the "incomprehensible demoralization" of addiction. She wants to train and educate, not penalize and reprimand. And if, in the course of education, soldiers identify themselves or others as possible abusers, she is there to help.

Hill developed a driving desire to help abusers of drugs and alcohol early in

her life. In college, she became sensitive to the tragedies of abuse when friends were killed by a drunk driver. When she joined the Navy in 1974, she requested a position in drug and alcohol rehabilitation. At that time, the Navy wanted only recovering alcoholics as alcohol abuse counselors. So Hill agreed to attend "90 Alcoholics Anonymous (AA) meetings in 90 days," a suggested procedure for people just starting alcohol and drug recovery.

She also did more. She went to AA almost every night for a year. Hill learned what a recovering alcoholic actually goes through during that first long year of recovery, and it helped her

to become a better counselor.

After five years as a counselor, Hill repeatedly witnessed addiction's destruction and wanted to prevent unnecessary suffering. She thought education was the way to deter users that were on the downward path to abuse and so she became the training instructor at Schofield. She has been there for five years.

For alcohol and drug abuse education, training and prevention, Hill is the person to talk to. However, Guard members who would like assistance concerning problems related to substance abuse and procedures for reserve status options should call Kathy Morigaki at 655-9113.

Drill pay up 4.2%

Reserve drill pay is expected to increase 4.2 percent Jan. 1, 1992, for members of the Selected Reserve. The increase, which matches the 1992 basic pay raise that President Bush is expected to approve, will apply to most of the 1.1 million members of the National Guard and Reserves.

The chart shows the pay for a single drill. In practice, each day of a typical weekend drill counts as two drills, so members may calculate the value of a weekend drill by multiplying the appropriate figure in the chart by four. For example, an E-7 with 14 years of service will get a pay increase of \$2.55 per drill in 1992, or \$10.20 per weekend.

About 70,000 selected reservists are not drilling because they were activated for the Persian Gulf emergencies or are on full-time active duty.

National Guard drill pay effective Jan. 1

Here are the one-day reserve drill rates that will be effective Jan. 1, 1992, reflecting the 4.2 percent raise approved by Congress and expected to be signed by President Bush. In general, a weekend drill is worth four one-day drills.
