A candidate for the Fifth Representative District seat until this morning, Kepoo said he has been called to active duty by the Hawaii Army National Guard under the recent mobilization order.

Kepoo said his name will not be on the ballot in the June 1 election.

He said he has not decided to whom he will give his support.

"I will talk with my supporters in Kona tomorrow (Friday) before I'll make my announcement about my support to another candidate," Kepoo said.

Kepoo, a Republican, was defeated twice in races for the County Board of Supervisors.

Kepoo's withdrawal will leave six candidates in the race for the Fifth District seat which encompasses Kohala and North Kona.
